關於山頂廣場進行外牆提升工程期間 臨時局部封閉山頂道花園及兒童遊樂場的意見


根據二零一六年十一月三日舉行的地區管理委員會會議和所發出的會議記錄,凱達環球代表恆隆回應地區管理委員會提出的問題如下: -

- 1. 經過項目顧問小組的仔細研究,改動工程計劃及施工程序後,同意將臨時封閉康樂及文化事務署轄下山頂道花園的時間由 24 個月縮短至 18 個月及於第十五個月後縮小封閉範圍(見附件1)。在縮短工程期間及封閉範圍內,我們會優先完成商場外部工程(例如結構改裝及玻璃幕牆安裝工程等)以及封閉範圍內的復修工程。餘下工作則會在商場內進行。
- 2. 現時申請的臨時封閉區範圍已是可行情況下最小的,其用途如下:
- a. 拆除現有入口大型金屬架,電梯塔和其他外牆結構(例如鋼筋混凝土 結構及玻璃幕牆等)。
- b. 興建新玻璃幕牆和其他外牆部份。 我們會於完成搭建大型組件及圍封範圍之復修工程後立即開放封閉 範圍。
- 3. 現時臨時圍封範圍僅足施工需要,詳情如下:
- 在施工現場和公共區域之間設置安全區,用作興建金屬圍板、棚架、 有蓋人行通道和工作平台,保障公眾和施工人員的安全。
- 提供足夠安全操作空間予移動式起重機及車輛出入。
- 設立樹木保護區(見附件2)。
- 保持應急救援通道暢通。
- 山頂廣場之外牆組裝過程已經考慮因應時間及空間限制而使用預先 組裝的玻璃幕牆組件以減少現場組裝工程所需時間及空間。
- 4. 我們已應地區設施管理委員會要求,去信要求警方加強打擊非法的士 接載服務(見附件3)。在工程開展期間,我們會配合警方的交通安排。

5. 我們會應地區設施管理委員會要求定期提交有關工程進度的報告加強溝通。

<u>DFMC meeting minute No 5, item 25 – Request for strengthen measures to eradicate illegal taxi services during the construction period</u>

We have been commissioned by Hang Lung Project Management Limited, as a lead consultant for the major revamp at the Peak Galleria located at The Peak.

An application has been made to Leisure and Cultural Services Department for seeking their consent for temporary closure of partial Peak Road Garden for the necessary construction activities to be carried out.
