

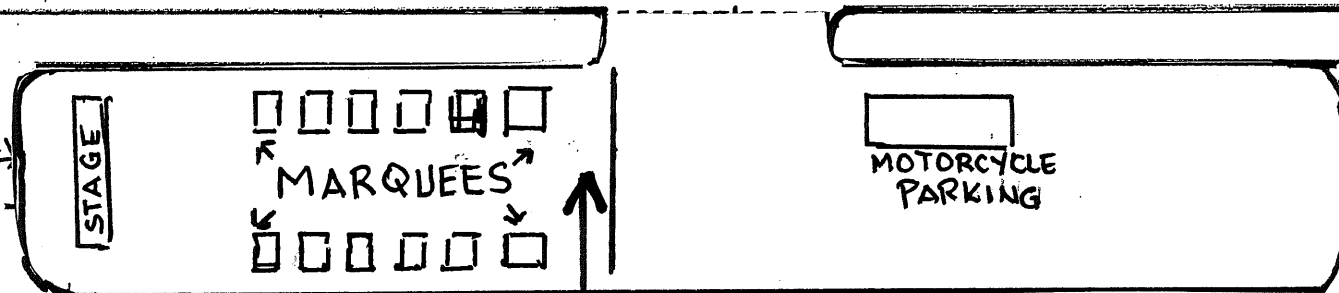

Based on the information you have provided and our on-site risk assessment, we have no objection in principle to your application from the fire safety point of view. Please be reminded that you must inform this Department as soon as possible of any deviation from the actual situation/changes in the information provided, or any essential information omitted in your application for further risk assessment by this Department. Such information includes, but is not limited to, the mode of operation of the entertainment activity concerned, the types of props/apparatus to be used, special effects to be produced, etc. Further fire safety requirements may be imposed on your application if required.

The fire safety requirements (PPA/106) are attached for your compliance. Please inform this Department upon compliance with these requirements for our arrangement of follow-up inspection(s). In accordance with Regulation 3 of the Fire Services Department (Reports and Certificates) Regulations, Cap. 95C, Laws of Hong Kong, a fee of **HK\$1,190.00.-** shall be payable by the applicant to this Department in respect of the issue of certificate. Please pay the fee on or before **25.11.2016**. A Fire Services Certificate will be issued upon your compliance with all the requirements and production of the proof of payment to the inspection officer(s). The Fire Services Certificate will NOT be issued, or any Fire Services Certificate already issued will be invalidated, if you fail to provide information on any undue fire risk or life risk to participants which may be posed by the activity to this Department for risk assessment.

Please pay in cash or by a crossed cheque made payable to "The Government of the Hong Kong Special Administrative Region" or "The Government of the HKSAR". A receipt will be issued by this Department upon receiving the payment. The payment methods are as follows:
