Welcoming Remarks

<u>The Chairman</u> welcomed Members and representatives of departments to the 5th meeting of the Finance and Administration Committee (FAC) of the Sai Kung District Council (SKDC) in 2016.

2. <u>The Chairman</u> reported that Mr Philip LI was unable to attend the meeting as he was out of town and had given a Notification for Absence from Meeting to the Secretariat before the meeting. There being no objection from Members, the Chairman declared that the application for absence from meeting was approved in accordance with Order 51(1) of the Sai Kung District Council Standing Orders (Standing Orders).

I. Confirmation of Minutes of the Fourth Meeting of FAC in 2016

3. There being no amendment from Members to the minutes of the fourth meeting, <u>the Chairman</u> declared that the above minutes of meeting were confirmed.

II. Report Items

- (1) Financial Status of Sai Kung Community Involvement Funds 2016-2017 as at 15 September 2016 (SKDC(FAC) Paper Nos. 28/16 to 29/16)
- 4. Members noted the above papers.
- 5. <u>The Secretary</u> reported the financial position of the 2016-17 Sai Kung Communicty Involvement Funds. As at 15 September 2016, the total approved commitment of the Sai Kung Community Involvement Funds was \$15,360,732.22 and the total actual expenditure was \$7,904,355.80.
- 6. Members noted that there were remaining allocations for the following projects and it was expected that there would not have any other funding applications of these projects for the current financial year. The projects with remaining allocations included:
 - "Mid-Autumn Festival Lightings for Residents' Organisations": remaining allocation of about \$49,000;
 - "Healthy City and Safe Community Accreditation" and "Partnership projects": a funding amount of about \$140,000 was allocated to the Social Services & Healthy and Safe City Committee (SSHSCC) under "Partnership projects" for organising the Age-Friendly Summit and training of Age-friendly Ambassadors. It was estimated that the remaining allocations for "Healthy City and Safe Community Accreditation" and "Partnership projects" would be \$550,000 and \$200,000 respectively after deducting the above-mentioned funding amount of about \$140,000. SSHSCC endorsed returning the remaining allocation to FAC for other uses at its meeting on 27 September 2016; and
 - "Reserve/Contingency": remaining allocation of \$99,000.

The total amount of the above remaining allocations was \$898,000.

- (2) Variations of Projects (SKDC(FAC) Paper No. 30/16)
- 7. Members noted the above paper.
- 8. Members noted the activity "The Big Buddha & Tai O One Day Tour" (Application Number: 58/16-17(CRS)) set out in item 1 of the paper which was organised by the Owners Committee of the Grandiose. The activity was originally called "National Day Fireworks Display Tour" and its nature was changed from viewing fireworks display on spectator vessels to visiting Ngong Ping Village, Po Lin Monastery, the Giant Buddha and Tai O under the application for variation of projects. In 2015, a residents' organisation also submitted an application for variation of project to change the nature of its activity from a visit to the museum and barbecue activity to squid fishing. Members at that time opined that as there were substantial changes in the nature and date (to be postponed for more than 2 months) of the proposed activity, the application for variation of project was not endorsed and the grantee had to submit a new application to FAC.
- 9. There being no objection from Members, the Chairman declared that the Owners Committee of the Grandiose was required to submit an application again for its activity "The Big Buddha & Tai O One Day Tour" (Application Number: 58/16-17(CRS)) because the nature of the activity was significantly different from the description on the original application. He also declared that the new application would be vetted by circulation of paper before the next FAC meeting.
- 10. There being no objection from Members, the Chairman declared that all applications for variation of projects under items (2) to (7) of the above paper were endorsed according to paragraph 71 of the Guidelines/Procedures on the Use of Sai Kung District Council Funds for Community Involvement Projects ("the Guidelines").
- 11. Some Members said during planning and preparation of projects, all grantees should avoid as far as possible submitting post-event applications for amendment or variation of their projects. Even if the District Council endorsed a post-event application for variation of project at its discretion, the Secretariat should, upon endorsement, give a written notification to inform the relevant grantee that the endorsement was an exceptional case only.
 - (3) Reports of Working Groups established under FAC
 - (a) Report of Working Group on Arts and Cultural Activities (SKDC(FAC) Paper No. 31/16)
 - (b) Report of Working Group of Publicity and Editing (SKDC(FAC) Paper No. 32/16)
- 12. The Secretary of the Working Group on Arts and Cultural Activities and the temporary convenor of the relevant meeting of the Working Group of Publicity and Editing briefly introduced the above papers respectively.
- 13. Members noted the above papers.
- 14. There being no objection from Members, the Chairman declared that the above two progress reports were endorsed.

III. Discussion Items

- (1) Applications for 2016-2017 Sai Kung Community Involvement Funds Submitted for Endorsement at the Fifth Meeting of FAC in 2016 (SKDC(FAC) Paper Nos. 33/16 and 34/16)
- 15. The Chairman asked Members to note the information on declaration of interests made by Members in SKDC(FAC) Papers No. 33/16 to 34/16. The Secretariat did not receive any updated information on declaration of interest and had sent the latest information on Members' declaration of interests to all Members by email before the meeting. If Members found any incorrect or missing information on the paper, they were requested to make a declaration immediately and complete the declaration form after the meeting for the Secretariat's record. In addition, Members should declare interests or update the information before the meeting for the Secretariat to send the information on Members' declaration of interests to all Members by email for reference. If Members present at the meeting had any doubt about the information or the relationship with an organisation as declared by a Member, they should raise it immediately at the meeting for discussion and resolution by FAC.
- 16. The Chairman said the funding applications submitted to FAC for consideration had been vetted by the Secretariat based on the Guidelines before they were recommended to FAC for approval. If there was no provision under the existing items listed in the Guidelines for a particular funding item under request, the item would be regarded as "non-standard item". Members could decide whether funding should be granted for such "non-standard item". Members were asked to vet the funding applications prudently with a view to making more effective use of resources.
- 17. <u>The Chairman</u> reported that there were a total of 39 funding applications for projects in 2016-17 and the total funding amount recommended for approval was \$2,240,807.80.
- 18. The Secretary reported on the following projects:
 - As the allocation for Civic Education activities for the current financial year was fully utilised, there would be an over-provision of \$22,210.00 if the total funding amount recommended for approval was endorsed.
 - A total funding amount of \$180,000.00 for Road Safety activities was recommended for approval and the expenditure of this project would be settled by the allocation for "Healthy City and Safe Community Accreditation" and "Road Safety" at \$100,000 and \$80,000 respectively.
 - As the allocation for District Facilities Management Committee (DFMC) Partnership Projects for the current financial year was fully utilised, there would be an over-provision of \$405,276.00 if the total funding amount recommended for approval was endorsed. However, the project "Supporting Activities for Athletes Representing Sai Kung District in the 6th Hong Kong Games" (Application Number: 5/16-17 (DFMC)) was a cross-year project and most of its expenditure (about \$110,000) would be settled in the next financial year. In this connection, the estimated expenditure of this project in the current financial year was \$50,000 only. As a result, there would be an over-provision of \$295,276 for DFMC Partnership Projects in the current financial year.
- 19. The details of the approval results after discussion were set out in the **Annex**.

(2) Allocation of Remaining Funds in 2016-2017 (SKDC(FAC) Paper No. 36/16)

- 20. The Secretary reported that the remaining allocation for the current financial year was currently estimated to be \$898,000. After deducting the total amount of over-provisions arising from the funding applications approved by FAC at this meeting, the remaining allocation of the District Council Funds was about \$580,000 at present. In addition, funding applications for the following projects might be received in the remainder of the financial year according to the information obtained by the Secretariat:
 - Lunar New Year Celebration to be organised by Tseung Kwan O (North) Area Committee with a funding amount of about \$40,000 to \$50,000; (Note: If the funding application was approved, there would be an over-provision of about \$20,000.)
 - Kick-off Ceremonies for the projects under the Signature Project Scheme (SPS) with a funding amount of about \$80,000;
 - Seminars and visits to be organised under Building Maintenance of Community Affairs with a total funding amount of about \$16,000;
 - Activities promoting Sai Kung Ancient Trail and night visit to the East Dam of High Island Reservoir to be organised by the Working Group on Tourism and Economic Development; and (Note: The remaining allocation for "Promotion of Economy in District" under the
 - Working Group on Tourism and Economic Development was about \$100,000.) The Age-Friendly Summit and training of Age-friendly Ambassadors with a funding amount of about \$140,000.
 - [Note: SSHSCC had earmarked an allocation of about \$140,000 for organising activities under "Partnership projects".]

Therefore, after deducting the funding allocation to Tseung Kwan O (North) Area Committee and the allocation for the above projects under SPS and Building Maintenance of Community Affairs, it was estimated that the total amount of remaining allocation of the District Council Funds would be about \$464,000.

- 21. Members noted SKDC(FAC) Paper No. 36/16.
- 22. Some Members opined that if Hang Hau Rural Committee would invite Tseung Kwan O (South) Area Committee and Tseung Kwan O (North) Area Committee to jointly organise activities such as Sai Kung District Cantonese Opera Shows 2017 as well as dragon and lion dance activities in celebration of the Spring Lantern Festival, these activities would achieve greater success while facilitating all residents in Tseung Kwan O New Town to experience traditional rural culture and jointly celebrate Lunar New Year with residents in the rural area of Hang Hau. Therefore, the Members supported the proposal raised by the Working Group on Organising Festival Celebrations to provide additional resources for "Lunar New Year Celebration" and "Lunar New Year Programme of Rural Culture".
- 23. Besides, some Members said Hang Hau Rural Committee did not plan to organise other lion and unicorn dance activities as it did in the past after organising the dragon and lion dance activities in celebration of Lunar New Year/Spring Lantern Festival, thereby saving an allocation of \$30,000 originally earmarked for Hang Hau Rural Committee. In other words, the actual increase in funding allocation for "Lunar New Year Programme of Rural Culture" was \$170,000 in total.

24. There being no objection from Members, the Chairman declared the granting of a total additional allocation of \$466,450 for "Lunar New Year Celebration" and "Lunar New Year Programme of Rural Culture" was approved. The details would be reported at the next full council meeting of SKDC.

- 25. Members noted the pay adjustment of SKDC staff.
