## Progress Report of Sai Kung District Council <u>District Facilities Management Committee</u>

The second meeting (2017) of the Sai Kung District Council District Facilities Management Committee (DFMC) was held on 14 March 2017. The major issues discussed at the meeting were summarised as follows:

<u>Improvement of the project endorsement procedure and review of the pending District Minor Works Projects</u>

1. The DFMC endorsed the document titled "Improvement of the project endorsement procedure and review of the pending District Minor Works Projects", and decided to implement the proposals put forward in the document.

Funding Proposal: "Carrying out emergency facility improvement works of small-scale for the recreation and sports facilities of the Leisure and Cultural Services Department (LCSD) in the Sai Kung District (2017/18)"

2. The DFMC endorsed the funding of \$1 million for the LCSD to implement the works.

Community Involvement Project Funding Application: "Funding application from Sai Kung Primary Schools Area Committee of Hong Kong Schools Sports Federation (HKSSF) for the School Sports Developmental Programme in 2017"

3. The DFMC proposed the funding of \$265,947 for the Sai Kung Primary Schools Area Committee of the HKSSF to implement the above programme.

Matters Arising: "Request to arrange for mobile library services at an appropriate location at LOHAS Park"

Matters Arising: "Request to follow up on the construction and future operation of the Hong Kong Football Association's football training centre in Area 77 and to make good preparation for its interfacing with the periphery leisure facilities to produce complementary and synergistic effects"

4. The DFMC endorsed keeping the above issues.

Works Proposal: "Suggest building a rain shelter on Po Yap Road (opposite Park Central)" Works Proposal: "Suggest constructing a rain shelter for the footpath on Chui Ling Road (near the substation of CLP)"

6. The DFMC agreed to follow up on the proposals, and asked the Works Section of the Sai Kung District Office (SKDO) to explore the feasibility of the works.

Works Proposal: "Install drinking fountains at Tseung Kwan O Waterfront Promenade (the section from Northern Bridge to LOHAS Park)"

Works Proposal: "Fix railings for the trail from Tseung Kwan O West Low Level Service Reservoir to Tsui Lam Road"

7. The DFMC agreed to follow up on the proposals, and asked the relevant departments to explore the feasibility of the works.

Member's Motion: "Request for relocating some of the planters in the flower beds of Yuk Nga Lane in Po Lam so as to enhance safety in driving"

8. The DFMC endorsed the motion, and asked the Works Section of the SKDO and the Secretariat to follow up.

Member's Motion: "Request the LCSD to improve the design of the gate of the Pet Garden in Area 77"

9. The DFMC endorsed the motion, and asked the Secretariat to write to the Environmental Protection Department.

Member's Motion: "Request for extending the model boat pool in the Hong Kong Velodrome Park, and exploring the feasibility of converting the artificial lake into a model boat pool to meet the demands of the users"

10. The DFMC endorsed the motion, and asked the LCSD to follow up.

Relocation of the flower pots of the District Council on Mau Yip Road near Po Fung Road

11. The DFMC noted the above issue.

<u>Covered walkway project</u>12. The DFMC noted the three covered walkway works proposals that met the requirements set out in the Policy Address, and agreed to convene a meeting of the Covered Walkway Working Group to discuss the issue.
