Briefing Note on 2011 Population Census

Introduction

It is an established practice since 1961 for Hong Kong to conduct a population census every ten years and a by-census in the middle of the intercensal period. Population censuses were conducted in 1961, 1971, 1981, 1991 and 2001 while population by-censuses in 1966, 1976, 1986, 1996 and 2006. Following this practice, the next round of population census will be conducted in 2011.

Objectives of Population Censuses/By-censuses

2. The aim of conducting population censuses/by-censuses is to obtain up-to-date benchmark information on the socio-economic characteristics of the population and on its geographical distribution. They provide benchmark data for studying the direction and trend of population changes. The data are key inputs for making projections concerning population, household, labour force and employment. Population censuses/by-censuses differ from other general household sample surveys in their sizable scale, which makes it feasible to provide statistics of high precision even for population sub-groups and small geographical areas. Such information is vital to the Government for planning and policy formulation and important to the private sector and academia for business and research purposes.

Legislation and Census Period

3. The Census and Statistics (2011 Population Census) Order has been made under section 9 of the Census and Statistics Ordinance to enable the conduct of the 2011 Population Census ("11C") from 30 June (Thursday) to 2 August (Tuesday) 2011. All persons specified under the Order are obliged to provide the required information.

Design of the Census

Questionnaires

4. Two types of questionnaires will be used in the 11C. Short form questionnaire will be used to enumerate about nine-tenths of households on basic characteristics of household members (e.g. year and month of birth and sex). Long form questionnaire will be used to enumerate the remaining one-tenth households on a broad range of socio-economic characteristics of household members. A scientific sampling scheme will be used to select households for enumeration by either the long form or short form questionnaire. Statistics on the size and characteristics of the population can be compiled by combining data of the short form and long form questionnaires through the use of statistical methods.

Census Reference Moment

5. During the 34-day census period of the 11C, factors such as births, deaths, arrivals and departures may lead to changes in the population size. Hence, there must be a standard time-point for enumerating the population and this time-point is called "census reference moment". The census reference moment for the 11C will be 3 a.m. on 30 June 2011.

Unit of enumeration

6. For land population, quarters will be taken as the basic enumeration unit. During the enumeration, information is recorded on a household basis, while individual persons are the ultimate targets of enumeration. Each unit of quarters may have more than one household and each household may have more than one member. As for marine population, the targets of enumeration are persons living in vessels.

Notification about the Census

7. The Census and Statistics Department ("C&SD") will send notification letters to all quarters¹ by phase during the period from 23 June to end June 2011 on the detailed arrangements of the 11C. For quarters without clear identifiable postal address (e.g. households in the rural areas using communal letter boxes), marine population and non-residential buildings with persons living therein, the C&SD will arrange census officers to visit the households concerned directly.

¹According to a frame of quarters, which comprises a list of addresses of permanent quarters in built-up areas and a list of area segments in non-built-up areas.

Multi-modal data collection approach

- 8. A multi-modal data collection approach will be used in the 11C under which the data collection process will be divided into two phases. In the first phase from 30 June to 15 July 2011, households are encouraged to choose self-enumeration mode through submission of an e-questionnaire online or by postal return (applicable to short form questionnaire only). For the remaining households not choosing self-enumeration mode, the C&SD will arrange census officers to conduct face-to-face interviews in the second phase, which will commence on 16 July 2011. The census officers will wear a uniform (green T-shirt with purple collar), carry a red satchel with the census logo and identify themselves with a Census Officer's Certificate of Identity issued by the C&SD.
- 9. Census officers will distribute a self-administered questionnaire to households that cannot be contacted during the second phase. The households concerned will be encouraged to return the completed questionnaire before a designated date to the C&SD by post.
- 10. In case clarification of the information provided by households is required, census officers will contact the households concerned by phone or visit.

Data topics

- 11. Same as the previous censuses / by-censuses, the following factors are considered in deciding the data topics for 11C:
 - (i) usefulness of data;
 - (ii) willingness and ability of the respondents to answer;
 - (iii) ability of enumerators to understand the questions and communicate with the respondents;
 - (iv) existence of other data source / data collection channel;
 - (v) processing efforts;
 - (vi) comparability of data with previous censuses/by-censuses;
 - (vii) keeping the interviewing time within reasonable length; and
 - (viii) recommendations of the United Nations and international practices.
- 12. Extensive consultations on the data topics for the 11C have been conducted. After consolidating the views received and taking into account the factors mentioned above, a total of 41 data topics have been included for the 11C. The data topics (see Annex 1) are basically the same as those of the 2006 Population By-census, but with suitable refinements to the classifications.

Data confidentiality

13. The C&SD will implement strict procedures to ensure that all data collected in the 11C on individual persons and households will be handled in strict confidence for privacy protection. Under the Census and Statistics Ordinance, it is an offence for census officers to disclose particulars of individual persons or households to unauthorised persons. All completed questionnaires will be destroyed within one year after the commencement of the Census.

Census Results

14. Findings of the 11C will be released by phase starting from February 2012. Detailed statistics for individual District Council districts will be published through various means including publications and the 11C website (http://www.census2011.gov.hk). In the meantime, up-to-date statistics for District Council districts are available from the continuous General Household Survey. Key statistics for 2010 are presented in <u>Annex 2</u> for reference.

Support for the Census

- 15. The successful conduct of the 11C relies on the support from the wide community. The C&SD would like to solicit members' support to:
 - (i) publicise the conduct of the 11C to residents in your district, and in particular, request households to cooperate and provide the information required accurately; and
 - (ii) advise on any special operational arrangements required in your district to facilitate the conduct of fieldwork.

The data topics 'Mortgage payment or loan repayment', 'Other cash income' and 'Number of rooms in the residence' include more than one data item.
