## Memorandum for Sai Kung District Council Progress Report of Sai Kung District Council Finance and Administration Committee

The second meeting (2004-05) of the Sai Kung District Council (SKDC) Finance and Administration Committee (FAC) was held on 17 June 2004. The major issues discussed are summarized below:

#### Financial Position of SKDC (2004-05)

#### (SKDC(FA) Paper Nos. 10 and 12/04-05)

#### (SKDC(FA) Paper Nos. 11 and 13/04-05 (Revised) Tabled at the Meeting)

- Members noted the financial position of the SKDC (2004-05) as set out in the captioned papers. As at 25 May 2004, the amount of fund approved by the SKDC for:
  - Culture, Recreation and Sports Activities was \$721,575.9 and the actual expenditure was \$0.0;
  - ii. Festive Celebrations was \$838,560.0 and the actual expenditure was \$0.0;
  - Community Affairs Activities (earmarked fund) was \$427,074.0 and the actual expenditure was \$0.0;
  - iv. Community Affairs Activities (non-earmarked fund) was \$408,746.0 and the actual expenditure was \$0.0; and
  - Publicity and Miscellaneous Items was \$115,700.0 and the actual expenditure was \$0.0.

# Review on the Guidelines/Procedures on the Use of Sai Kung District Council Funds for Community Involvement Projects (CIPs), District Festivals Subsidy Schemes (DFSSs) and District Cultural Project Grants Schemes (DCPGSs) (SKDC (FA) Paper No.15/04-05)

3. Members proposed some amendments after reviewing the Guidelines/Procedures on the Use of Sai Kung District Council Funds for CIPs, DFSSs and DCPGSs. The amendments were then endorsed at the meeting and referred to the SKDC third plenary meeting (2004-05) to be held on 3 August 2004 for confirmation.

4. Members noted a total of 77 funding applications were set out in the captioned paper

with funds applied for amounting to \$1,299,158.9. Among these applications:

- 47 belonged to Cultural, Recreation and Sports Activities and the total amount applied for was \$556,970.4;
- ii. 1 belonged to Festive Celebrations and the total amount applied for was \$17,200.0;
- iii. 3 belonged to Community Affairs Activities (earmarked fund) and the amount applied for was \$68,190.0;
- iv. 23 belonged to Community Affairs Activities (non-earmarked fund) and the amount applied for was \$401,798.5; and
- v. 3 belonged to Publicity and Miscellaneous Items and the amount applied for was \$255,000.0.
