The third meeting (2004-05) of the Sai Kung District Council (SKDC) Finance and Administration Committee (FAC) was held on 19 August 2004. The major issues discussed are summarized below:

Financial Position of SKDC (2004-05)

- Members noted the financial position of the SKDC (2004-05) as set out in the captioned papers. As at I August 2004, the amount of fund approved by the
 - Cultural, Recreational and Sports Activities was \$1,278,546.30 and the i. actual expenditure was \$104,220.30;
 - Festive Celebrations was \$838,560.00 and the actual expenditure was ii. \$0.00:
 - Community Affairs Activities (earmarked fund) was \$512,464.00 and iii. the actual expenditure was \$0.00;
 - Community Affairs Activities (non-earmarked fund) was \$ 877,544.50 iv. and the actual expenditure was \$50,913.70; and
 - Publicity and Miscellaneous Items was \$370,700.00 and the actual V. expenditure was \$665.00.
