目的

本文件旨在請各議員就有關議題發表意見。

背景

2. 歐立成議員、柴文瀚議員、高譚根議員、楊小壁議員及徐是雄議員一同以書面提出，要求在 2006 年 1 月 5 日舉行的南區區議會第十四次會議上，討論有關「香江大舞台」的公眾娛樂場所牌照續牌申請事宜（見附件一）。

3. 按照南區會議常規（2004-2007）第 13 條，南區區議會主席同意將有關議題納入南區區議會第十四次會議的議程。有關「香江大舞台」的公眾娛樂場所牌照續牌事宜，食物環境衛生署提供的資料載於附件二。至於「香江大舞台」對華薄區一帶造成的環境衛生及交通安全問題，食物環境衛生署、香港警務處及運輸署提供的資料載於附件二至附件四，供議員參閱。


南區華景街 4 號華富閣『香江大舞台』的運作情況，已對華薄區構成交通安全及環境衛生問題，並引起附近居民不滿。

食物環境衛生署提供的資料

「香江大舞台」位於香港仔華樂徑 4 號華富閣，於 2005 年 4 月 6 日獲發公眾娛樂場所牌照。根據《公眾娛樂場所條例》(第 172 章)，民政事務局局長為公眾娛樂場所牌照發牌當局，而食物環境衛生署人員獲民政事務局局長授權發出上述牌照。

2. 「香江大舞台」分為一院及二院，分別可容納不多於 792 人及 472 人。一院可用作劇院、舞台表演及播放電影；二院則只可用作播放電影。

3. 本署近月接獲投訴，指「香江大舞台」的觀眾量大增，引致交通和環境衛生等問題。在環境衛生問題方面，投訴主要集中於在公眾地方隨處拋棄垃圾、吐痰和方便，投訴人要求本署增設廢屑箱及加強潔淨服務。另外，部分投訴亦涉及上述處所通風系統發出噪音及超收觀眾的情況。

4. 本署人員在接獲投訴並進行調查後，已在上址加設廢屑箱和加強街道潔淨次數，並在附近宣傳清潔香港訊息。在 2005 年 12 月 16 日的一次突擊行動中，本署人員在上述地點附近檢控一名違例在公眾地方小便的人士。本署會繼續密切留意有關情況及作出適當的跟進行動。至於噪音問題，本署已把事件轉介環保署處理。在調查中，本署並沒有發現場內觀眾超出批准的人數。

5. 「香江大舞台」現時的牌照有效期至 2006 年 4 月 5 日，本署已接獲該處所的續牌申請，現正根據《公眾娛樂場所規例》(第 172A 章)處理其續發牌照的申請，並按條例的規定諮詢消防處處長及屋宇署署長的意見。

香江大舞台所衍生之交通擁塞及厭惡性投訴

背景

華富邨位於香港島西南方，可經從薄扶林道、域多利道及華富道進入。該邨已有三十多年歷史，其道路主要是提供邨內居民使用。除薄扶林道外，其他道路皆狹窄彎曲，不能應付繁重的交通流量或供車輛在路旁停泊，對大型車輛的行駛亦構成潛在危險。

2. 邨內以往有一所戲院，即現今之香江大舞台（大舞台），因缺乏市場需求，已棄用多年，2005年初有企業商人發掘其潛在用途，於同年4月起，每日由1700時開始安排數場泰國人妖表演。大舞台獲食物環境衛生署發出公共表演牌照得以經營，相關牌照法例及限制見於附件“A”。

3. 由於該演出引起邨民對交通及環境問題作出大量的投訴，故令政府部門關注到是否應該容許該表演在上址繼續，這份文件將考察現況及提出討論。

大舞台活動背景簡介

4. 在2005年4月6日，食環署發給大舞台一年之公共表演牌照。在開始時，大舞台每天安排三場表演，分別為1700時、18時30分及20時15分，每場約一小時，每場並有約800名觀眾入場。觀眾主要為內地遊客，他們乘坐約共30部不同大小的旅遊巴士到達及離開表演場地。從2005年11月13日起，表演場數增至平日每天五場，週末六場，時間為16時15分、17時30分、18時45分、20時、21時15分及22時15分，明顯地將每場表演的相隔時間減至15分鐘。

衍生問題

(A) 交通擠塞

5. 如第一段所述，華富邨內之道路結構並不適宜大量的車輛接載觀眾到達及離開該舞台。下述兩個因數更加深了問題的嚴重性：

- a. 因每場表演歷時一小時，旅遊巴士司機並沒有足夠的時間離開及返回接載客人，促使車輛必須逗留在街道上；現時司機是將巴士停於屋邨內、石排灣道或域多利道。如上文提及，這些都是狹窄的道路，尤其是域多利道，每當一輛旅遊巴士停於行車線上，其他的車輛便不能使用，當有警員上前，司機便將車輛駛離，但依然逗留區內，導致區內道路受到一定程度上的擠塞。
- b. 在相隔完場及開場的 15 分鐘內，不但有大量旅遊巴士在大舞台附近排隊等候接載觀眾離開，同時更不停有數量相若的巴士接載下一場觀眾到達。由於該區道路結構未能容納超過 60 部旅遊巴士，最終導致車輛爭相停泊的情況。

(B) 對行人之潛在危險

6. 該區行人路原非為容納大量人流而設計，每當為數 1600 名觀眾使用該段行人路時，很多觀眾因未能使用行人路，而走出馬路，穿插於旅遊巴士間，這情況十分危險，長遠而言，是不可接受的。

(C) 環境及民生影響

7. 大量巴士停泊區內，常開動引擎及冷氣，產生噪音及廢氣，使區內環境質素嚴重下降；隨地拋棄垃圾及吐痰的情況亦影響環境衛生，區內居民因要忍受環境污染、因旅遊巴士停泊而導致的交通擠塞及不能使用行人路，而作出大量的投訴，是可以理解的。

警方的行動

人群控制

8. 為確保基本的秩序及安全與及減低交通意外發生，警方不得不每日

從本警區調派四至八名警務人員在現場進行多小時的維持秩序工作。而這些爲了服務個別的商業機構的資源調配，導致其它地方的警力相對地減少。

與香江大舞台的負責人商討

9. 爲解決上述所引起的問題，警方亦已多次與香江大舞台的負責人聯絡商討，希望找出可行的解決方法。雖然香江大舞台的管理層亦作出改善措施；包括租用海洋公園內之車位及實施潮汐式人群管理等，但是所得到的效果並不明顯。有關的負責人更聲稱在本年底將會有一個可容納 30 部旅遊巴士的停泊地方並可供乘客作上落點。

10. 警方亦就可供旅遊巴士停泊的地方一事與房屋署，地政署及食物環境衛生署進行商討。

執法行動

11. 鑒於香江大舞台近日增加了表演場數，令交通擠塞及非法停泊的情況惡化，故警方亦相對地加強了執法。有關的比較結果如下：

12. 在此我們必須強調，警方的加強執法只會將泊車問題推到另一地方。因爲司機只會改在其它範圍停泊巴士或在附近作循環徘徊，根本解決不到因爲大批旅遊巴士在上址出入所造成嚴重交通負荷的問題。再者，由於每日的表演場數過密，所以接送遊客的旅遊巴士爲配合接送時間而不能將車輛停泊在較遠的位置，而最終停泊在香江大舞台附近一帶等候。

建議改善措施

➤ (在給予時間內減少人流)

- ✓ (減少表演場數，每日最多只可演出四場)
(因此每場表演之間可以有更長的相隔時間)
- ✓ (每場表演之間加設有一小時的相隔時間)
(因此便能減少因由接送的旅遊巴士或旅客所產生的衝突)
- ✓ (取消自由座位選擇，引入定票定位制入坐)
(因此排除旅客因爭先恐後地進入香江大舞台而獲得最佳座位的情況)

➤ (減輕與交通有關的問題)

- ✓ (要求有關舞台負責人增加人手協助，更有效率地管制停泊在海洋公園內與及在舞台附近的旅遊巴士的進出)

總結

13. 總括而言，除非警方建議的改善措施被有關機構所採納，否則不可能改善上述所衍生的問題，個中的原因是華富邨一帶地方在基建上根本是不足夠容納大量人流及車輛的同時使用。警方長期性地調配人手在上址執行工作是資源浪費，並嚴重地削弱了其它地區的警力；此事正正引起了區議會、撲滅罪行委員會及公眾人士的關注，甚而作出了大量的投訴（有關投訴的記錄請見附件 A1 及 A2）。反映出公眾對大舞台及政府部門在未能改善情況的不滿。

- 1) 為施行本條例而發出的牌照，其條款須由批出該牌照的發牌當局決定，而在不抵觸依據根據第 7(1)(ac)條所訂規例而作出的任何事情下，須受牌照內所指明的條件(如有的話)規限。
- 2) 在不影響第(1)款的一般性的原則下，該款所提述的條款或條件可—
 - (a) 指明該牌照維持有效的期間；
 - (b) 指明與該牌照有關的場所可於並只可於何等時間作公眾娛樂用途(在任何一日)；
 - (c) 藉提述日、月或星期而指明該等場所可於並只可於 1 段或多於 1 段的期間作此用途；
 - (d) 規定持牌人須採取的指明措施，或規管或禁止持牌人作出指明作為，而此等措施或作為是與維持人群秩序有關的；
 - (e) 規定持牌人在與牌照有關的場所作此用途時的任何時間，提供數目充足的急救人手以確保在顧及使用該場所進行的娛樂的性質後有足夠的急救服務提供；
 - (f) 就與牌照有關的場所內所進行的娛樂，指明可准予入場的最高人數，而任何上述條款或條件均可就一般的娛樂，指明可准予入場的最高人數，或就不同級別或類別的指明娛樂，指明 2 個或多於 2 個的可准予入場的最高人數。
- 3) 凡在施加條件的情況下批出為施行本條例而發出的牌照，批出該牌照的發牌當局可按照根據第 7(1)(ac)條訂立的規例，將任何該等條件取消、免除或更改，或以其他該等條件取代，或由進一步的該等條件增補。
- 4) 在本條中，“急救人手”(first aid personnel) 指每一位均屬合資格施行急救的人。
