Opening Remarks

<u>The Chairman</u> welcomed all Members and government representatives to the meeting, and announced the appointment of Ms WU Bi-yen, Joyce and Mr QIU Jianxin as the co-opted members to the District Facilities and Works Committee (DFWC).

Handling Applications for Absence

2. Ms CHAN Hang, Mr LAM Wing-shing and Mr Joseph CHAN submitted notifications of absence from meeting before the meeting. The DFWC decided to give consent to Ms CHAN Hang on the ground of sickness, but not to give consent to Mr LAM Wing-shing and Mr Joseph CHAN on the ground that their applications for absence were unrelated to their capacity as District Council (DC) members or the functions of the DC.

Agenda 1. Confirmation of the Draft Minutes of the 4th Meeting of District Facilities and Works Committee

3. The above draft minutes were confirmed without amendment.

Agenda 2. Progress Updates on District Library and Residential Care Home for the Elderly in the Joint User Complex at Lei King Road (DFWC Paper No. 18/2024)

- 4. <u>The Chairman</u> said that the agenda item and No. (8) under matters arising would be combined for discussion for their relevancy.
- 5. The representative of the Leisure and Cultural Services Department (LCSD) briefed Members on Paper No. 18/2024.
- 6. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) Members enquired about the reason for naming the project "Sai Wan Ho

Complex".

- (b) Members suggested incorporating "check-in" elements into the interior design of the complex to attract more people.
- (c) Members enquired whether there was any public car park in the complex.
- 7. <u>The representative of the LCSD</u> noted Members' views and suggestions, and responded to their views and enquiries as follows:
 - (a) With reference to past practices, the LCSD generally named new buildings with cultural, recreational and other facilities "complex". Therefore, the building on Lei King Road with a library and a residential care home for the elderly (RCHE) was named "Sai Wan Ho Complex".
 - (b) When preparing the interior decoration of the Sai Wan Ho Public Library, the LCSD would incorporate diverse design elements to attract public use of the library facilities and services.
 - (c) Regarding public car parks, the LCSD stated that as early as 11 July 2017, the Architectural Services Department had reported at the ninth meeting of the Planning, Works and Housing Committee of the Eastern District Council that according to its preliminary estimate, the construction cost of a single-storey underground car park would be about \$180 million to \$200 million and the cost per parking space would reach \$4 million while the overall timetable would be delayed for a minimum of two years. Therefore, no public car park would be provided in the complex, and only parking spaces would be provided for the daily operation of the library and RCHE, and for use by emergency vehicles. The details were available in paragraph 29(b) of the relevant minutes and item 1(1) of matters arising in Paper No. 23/17.

Agenda 3. Request for Provision of Seats along Leaping Dragon Walk (DFWC Paper No. 19/2024)

8. <u>A Member briefed the DFWC on Paper No. 19/2024.</u>

- 9. Members understood that the department had limited resources, and would like the department to consider the suggestion in the next financial year when resources permitted, and to arrange site inspections to improve the facilities at Leaping Dragon Walk.
- 10. The representative of the Eastern District Office (EDO) noted Members' views and suggestions, and responded that the EDO would consider allocating resources to renovate the facilities at Leaping Dragon Walk in the next financial year and study the feasibility of the captioned suggestion when feasible.
- 11. The DFWC agreed to follow up on the agenda item upon further progress.

Agenda 4. Suggestion for Comprehensive Inspection of Ageing Water Pipes in Public Housing Estates in Eastern District (DENIC P. A. 20/2024)

(DFWC Paper No. 20/2024)

- 12. <u>A Member</u> briefed the DFWC on Paper No. 20/2024.
- 13. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) Members enquired about the frequency for inspections and maintenance under the HomeCARE Programme of the department, and whether the inspection was carried out by the department or contractor.
 - (b) Members opined that even though the department carried out regular inspection and maintenance of public areas and public facilities in public housing estates (PHEs), there were still rusty, cracked and leaking pipes, and that regular inspection and maintenance once a year might not be enough to deal with ageing pipes. Members would like the department to provide information on enhancement measures at the next meeting.
 - (c) Members enquired about the number of PHEs in the Eastern District that required maintenance of communal drainage pipes under the Drainage Inspection Programme (DIP).

- (d) There was a rusty pipe near the roadside at Hing Wah (II) Estate. Photos would be provided to the department for follow-up.
- 14. <u>The representative of the Housing Department (HD)</u> noted Members' views and suggestions, and responded to their views and enquiries as follows:
 - (a) HD staff would carry out technical inspections, including assessment of the conditions of water supply facilities, at least once a year for all buildings in each PHE under HomeCARE Programme, and the contractor would carry out the maintenance.
 - (b) The HD would provide the number of PHE buildings inspected in the Eastern District under the DIP later.
 - (c) As the HD's works team mainly carried out visual inspection of drainage pipes, it might not be able to detect the conditions of drainage pipes located higher up in the building with 100% accuracy. Drone inspections were gradually being carried out, but they were yet to be extended to all PHEs. In addition, if the management staff of PHEs under HD found leakage in drainage pipes during routine inspections, they would immediately notify the works team for follow-up and maintenance as soon as possible.
 - (d) If Members found leakage in PHE drainage pipes, they could provide the relevant information and photos to the HD for immediate follow-up and maintenance.
- 15. The DFWC agreed to follow up on the agenda item at the next meeting.

Agenda 5. Concern about Ageing Water Mains and Enhancement of Water Supply Arrangement during Emergency Water Suspension in Braemar Hill Area

16. A Member briefed the DFWC on Paper No. 21/2024.

- 17. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) Members enquired whether the water mains leakages were caused by road maintenance works. They would also like the Highways Department (HyD) to step up communication with the Water Supplies Department (WSD) when carrying out road maintenance works.
 - (b) Members enquired of the WSD about the possibility of carrying out water mains improvement works during school holidays when there would be less vehicular traffic.
- 18. <u>The representative of the WSD</u> noted Members' views and suggestions, and responded to their views and enquiries as follows:
 - (a) There was no evidence that the water mains leakage was caused by road maintenance works, and the WSD would enhance the communication mechanism with the HyD.
 - (b) The WSD planned to carry out water mains improvement works as scheduled during school holidays when there would be less vehicular traffic. The WSD would continue to communicate with the Hong Kong Police Force on the situation.

They said that they had reported to the EDO that there were no special circumstances in their sub-districts since they could only rely on their inspection results during the typhoon and no notification had been received from the public. They would not like the EDO to interpret their reports as the actual situation for the entire sub-district.
- 38. The representative of the EDO noted Members' views, and responded that the reporting mechanism was intended for Members to report to the EDO when they learnt of special situations in the sub-district through community networks. The EDO would also learn about the conditions of the sub-districts from other local networks, and reports from Members and local networks could facilitate the EDO in understanding the latest situation of the sub-districts.

(ii) Suggestion for Sticker Design for Bridge Piers Supporting the Boardwalk underneath Island Eastern Corridor
