Action Opening Remarks

<u>The Chairman</u> welcomed all Members and government representatives to the meeting.

Handling Applications for Absence

2. Ms Joyce WU submitted notification of absence from meeting before the meeting. The District Facilities and Works Committee (DFWC) decided to give consent to Ms Joyce WU on the ground that she had to attend the funeral of an immediate family member.

Agenda 1. Confirmation of the Draft Minutes of the 6th Meeting of District Facilities and Works Committee

3. The above draft minutes were confirmed without amendment.

Agenda 2. Renaming of "Man Hong Street Playground" to "Man Hong Street Pet Garden"

(DFWC Paper No. 1/2025)

- 4. <u>The representative of the Leisure and Cultural Services Department (LCSD)</u> briefed Members on Paper No. 1/2025.
- 5. Members enquired about the opening hours of the Man Hong Street Pet Garden.
- 6. <u>The representative of the LCSD</u> replied that the Man Hong Street Pet Garden would be open 24 hours a day.

Agenda 3. Chai Wan Sports Centre Refurbishment Works (DFWC Paper No. 2/2025)

- 7. The representative of the LCSD briefed Members on Paper No. 2/2025.
- 8. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) During the refurbishment works of the Chai Wan Sports Centre, members of the public would have to go to other sports centres in the

- Eastern District to use the facilities. Members enquired the average number of users of the Chai Wan Sports Centre and whether other sports centres in the Eastern District could absorb them.
- (b) Members enquired whether renovation and repair works would be carried out at the fitness room at the Chai Wan Sports Centre, and whether the facilities in the fitness room would be replaced.
- (c) Members enquired whether the refurbishment works at the Chai Wan Sports Centre would include facility enhancements.
- (d) Members enquired whether the Chai Wan Sports Centre would be reopened to the public immediately upon completion of the works.
- 9. <u>The representative of the LCSD</u> responded to Members' views and enquiries as follows:
 - (a) According to records, there were around 9 000 to 10 000 monthly attendances at the fitness room at the Chai Wan Sports Centre. The other three sports centres with fitness rooms under the Eastern District Leisure Services Office, namely the Quarry Bay Sports Centre, Island East Sports Centre and Java Road Sports Centre, were expected to meet the demand given that all the existing fitness equipment was in normal operation.
 - (b) Replacement of the fitness room floor was part of the Chai Wan Sports Centre refurbishment works, and the fitness room had to be closed for the works. Also, the fitness equipment at the Chai Wan Sports Centre was functioning normally, and there was no plan to replace the equipment for the time being.
 - (c) The refurbishment works of the Chai Wan Sports Centre facilities included replacing the concrete floor of the arena with a wooden one. In addition, lockers with locks would be provided in the activity room to enhance security. The works would also renovate the barrier-free facilities to comply with the prevailing legal requirements.
 - (d) The LCSD would carry out the refurbishment works on the first and third

floors in two phases. Once the refurbishment works on each floor were completed, the facilities on that floor would be opened for public use. As the refurbishment works also included general public facilities such as corridors, individual facilities on the floors where the works were being carried out could not be opened for public use.

- 18. <u>The representative of the Eastern District Office (EDO)</u> reported on the latest work progress.
- 19. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) Members enquired about the conditions required for the location of the rain shelters.
 - (b) The original location where rain shelters would be built was the bus stop on Tin Hau Temple Road, Braemar Hill. As there were no trees or facilities to provide shade nearby, Members suggested building rain shelters at the location. Members thanked the EDO for its proactive response to the demands, but also understood that the works could not be carried out further as more pipelines were being laid underneath the nearby pedestrian walkway than originally expected. Members would propose another location for rain shelters near the original proposed

location, and hoped that the EDO would conduct further studies in the future.

- 20. The representative of the EDO noted Members' views and suggestions, and responded to Members' enquiry, pointing out that the proposed location of the captioned works was next to a slope and near a road junction. The EDO first consulted the relevant departments on whether the works would have any impact on the safety of the slope, and whether the rain shelters would affect traffic With the positive response from the relevant departments at that time, the EDO began to plan the design drawing of the rain shelters. However, given that the foundation of the rain shelters required sufficient depth to ensure structural stability, there was insufficient space to build a structurally stable foundation in the proposed location where the underground pipelines at the proposed location were only about 60 centimetres away from the ground and were very dense. Insisting on building a foundation at the location might damage the pipelines and would greatly affect the daily lives of nearby residents. Therefore, it was not possible for the EDO to proceed with the captioned works.

- 25. <u>The representative of the LCSD</u> responded to Members' views and enquiries as follows:
 - (a) The targets of the consultation included Eastern District Council (EDC)

Members, Aldrich Area Committee Members, and representatives of buildings within a 150 metre radius of the premises, including owners' corporations (OCs), mutual aid committees, property services management offices and schools.

- 32. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) Members hoped that the EDO would coordinate the use of government premises for hire by OCs in the Eastern District for general meetings.
 - (b) Members hoped that the EDB could provide incentives for schools to provide premises to OCs.
 - (c) Members requested the list of schools willing to provide their premises for hire and their contact details.
- 33. <u>The representatives of the EDO and EDB</u> noted Members' views and suggestions, and responded to their views and enquiries as follows:

EDO

(a) The EDO's Guidelines on Hiring a Community Hall/Community Centre (CH/CC) and its Facilities in the Eastern District stipulated a mechanism which accorded priority to OCs/owners' committees (OComs) to hire its facilities once each year for holding a general meeting. The EDO noted Members' views and hoped that the above priority mechanism could alleviate the demand for meeting venues by OCs/OComs in the Eastern District.

(b) As the conditions and restrictions for hiring premises varied among different schools, the EDB noted Members' views and would reflect them.

34. The DFWC agreed to follow up on the agenda item at the next meeting.

- (xvii) "Suggestion for Installation of Light Sensors in Public Housing Estates in Eastern District to Activate Public Lightings"
- 35. The representative of the HD reported on the latest work progress.
- 36. Members thanked the HD for promptly conducting an inspection with Members at Yiu Tung Estate and installing light sensors after the captioned agenda item was discussed at the meeting in November last year. Members also hoped that the HD would install light sensors at other locations in Yiu Tung Estate as well as other public housing estates in the Eastern District.
- 37. <u>The representative of the HD</u> noted Members' views and suggestions, and responded to their views as follows:
 - (a) As the installation of light sensors in Yiu Tung Estate was only completed at the beginning of the month, it was necessary for the HD to first observe the operation and effectiveness of the pilot points under adverse weather. Depending on the evaluation results of the pilot points, further studies would be carried out as necessary based on the actual situation.
 - (b) The HD noted Members' agreement that the HD should first evaluate the effectiveness of the pilot points before making corresponding arrangements.
