Action Opening Remarks

<u>The Chairman</u> welcomed all Members and government representatives to the meeting.

Agenda Item 1. Confirmation of the Draft Minutes of the 4th Meeting of Food, Environment and Hygiene Committee (FEHC)

2. The above draft minutes were confirmed without amendments.

<u>Agenda Item 2. Disposal of Domestic Waste on Shau Kei Wan Road</u> (FEHC Paper No. 15/2024)

- 3. A Member briefed the meeting on Paper No. 15/2024.
- 4. The views and enquiries of Members about the agenda item were summarised as follows:
 - (a) Members enquired whether the department would consider designating specific timeslots for private waste collectors to deposit waste to be removed in the street but taking enforcement action only when the waste was still deposited in the street beyond the specific timeslots.
 - (b) Members suggested the department liaise with the managers of "threenil buildings", owners' corporations (OCs) of buildings and private waste collectors on the arrangements for waste collection, install Internet Protocol cameras at littering blackspots, display banners to publicise the penalties for littering in public places and step up prosecution to achieve a deterrent effect so as to avoid waste disposal in public places.

Action

- (c) Members viewed that the provision of large-size waste containers in the street would require consideration of district planning and possible hygiene problems.
- (d) Members enquired about the number of housing estates and single-block buildings in the Eastern District using on-site domestic waste collection service.
- 5. The representative of the Food and Environmental Hygiene Department (FEHD) noted Members' views and suggestions, and responded to their views and enquiries as follows:
 - (a) Given that a permanent public refuse collection point (RCP) was already provided in the vicinity of the captioned location, the FEHD had to give careful consideration at the environmental hygiene perspective to the suggestion of providing additional temporary large-size waste containers in the street.
 - (b) The FEHD was not empowered to set a time period for allowing deposition of waste in the street. However, the relevant legislation already stipulated that no receptacle containing waste should remain in the street for a long time whilst awaiting the arrival of the waste collection vehicle.
 - (c) The FEHD had displayed banners and put up posters at the captioned littering blackspot in July to publicise the penalties for littering in public places. In addition, the FEHD would enhance communication with the managers of "three-nil buildings", OCs of buildings and private waste collectors to remind all stakeholders to make proper arrangements, and invite District Council members to assist in publicity and education.
 - (d) Buildings applying for on-site domestic waste collection service should be equipped with a suitable refuse storage chamber and provide a wide access road for refuse collection vehicles. However, most single-block buildings might fail to meet the eligibility criteria for the service as they might not have a suitable refuse storage chamber. Households of single-block buildings could either engage private waste collectors or transport their refuse to public RCPs managed by the FEHD on their

own.

6. The FEHC agreed to follow up on the agenda item upon further progress.
