Action Opening Remarks

The Chairman of the Eastern District Council (EDC) (the Chairman) welcomed all Members and government representatives to the meeting.

However, in order to tie in with the relevant follow-up work of the EDC in the coming year, he announced that the term of the WGBLE would be extended to 31 December 2025. The terms of reference of the WGBLE remained unchanged and were set out in Annex I of the captioned Paper, and the updated membership list was also set out in Annex II of the Paper. Any Member who wished to join or withdraw from the WGBLE had to seek the Chairman's approval through the Secretariat, which updated the membership list.
- 6. <u>The Chairman</u> announced the reappointment of Mr LAM Sum-lim as the Chairman of the WGBLE for the term ending on 31 December 2025 under Order 87 of the EDC Standing Orders.
- 7. The Chairman thanked Mr LAM Sum-lim for leading the WGBLE members to assist the Eastern District Office (EDO) in organising a series of activities to boost the economy of the Eastern District in the past year, and hoped that he would continue to give full play to his multi-faceted talents and bring more economic boosting activities for the Eastern District. He asked Mr LAM Sum-lim to express his views.
- 8. Mr LAM Sum-lim thanked the Chairman, the WGBLE members and the EDO staff for their support which had facilitated the smooth completion of the WGBLE's work in the past year. He was pleased to see all Members joining the WGBLE and hoped that they would work together and bring their strengths into full play in organising more economic boosting activities for the Eastern District.

<u>Follow-up on Key District Issues – Scaling Up Capability and Arrangements in</u> <u>Coping with Extreme Weather in Eastern District</u>

- 25. The Chairman pointed out that as Hong Kong had been hit by several typhoons and heavy rain in recent years, the Government had indicated in 2023 that it would endeavour to enhance the strategies and measures for scaling up capability and arrangements in coping with extreme weather. In view of this, the EDC identified "Scaling Up Capability and Arrangements in Coping with Extreme Weather in Eastern District" as a key district issue requiring research and attention at the meeting on 4 January 2024, which was subsequently followed up on by the DFWC under the EDC on an ongoing basis.
- 26. The Chairman remarked that the EDO had all along been striving to scale up the capability of the Eastern District in coping with extreme weather. To tie in with the "advance emergency preparedness" strategy, which was one of the four major strategies put forward by the Chief Executive, the EDO would arrange interdepartmental typhoon drills every year, and had co-ordinated a cross-unit typhoon drill among various government departments (including the Highways Department (HyD), FEHD, Leisure and Cultural Services Department and Drainage Services Department), the management office of Heng Fa Chuen and the Heng Fa Chuen Owners' Committee on 26 June 2024 to enable various units to get more familiar with the typhoon precautionary measures. The EDO and EDC were also highly concerned about the source causing flooding and channel blockages, and had been closely monitoring the construction sites in the district and reminding the departments concerned to cover the excavated materials before the onset of inclement weather so as to minimise the risk of flooding in the district at source. The EDO had also inspected the construction site of Ming Wah Dai Ha before the onslaught of Typhoon Yagi in September last year to ensure that the excavated materials were properly covered. Moreover, the EDO had been actively improving the wave barrier measures for coastal areas with higher risks, including the coastal enhancement measures to be carried out in Heng Fa Chuen subsidised by the Government. The Civil Engineering and Development Department was

now discussing with the MTR Corporation Limited on the details of the agreement

on the coastal enhancement works for Heng Fa Chuen, which would be formally

commenced thereafter.

27. The Chairman continued to add that to tie in with the other strategies put

forward by the Chief Executive, i.e. "decisive emergency response and speedy

recovery strategy", the EDO had activated the EDC's Adverse Weather Notification

Group for the first time when Hong Kong was hit by Typhoon Yagi in September

last year. Members reported the situation of their respective sub-districts during

and after the onslaught of the typhoon through the Group so as to enable the EDO's

referral to the government departments concerned for expeditious follow-up.

Also, the HyD had completed the emergency slope repair works at Yiu Hing Road,

which was now fully open to the public and special temporary traffic arrangements

were no longer required when the specified inclement weather warning signals were

in force.

28. The Chairman said that the EDO and the EDC would continue to scale up the

overall capability of the Eastern District in coping with extreme weather to minimise

the damage and impact brought about by extreme weather, with a view to enabling

the public to resume normal lives as soon as possible.
