The Marine Port District Action Plan for 2012 builds upon the successes of previous years and supports both Force and Regional Operational Priorities and Strategies.

OPERATIONAL PRIORITIES

Violent Crime

Against the Public

- Deter violent crime involving local youths, holidaymakers and residents.

Domestic Violence

- Reduce domestic violence by early intervention

Triads, Syndicated and Organised Crime

- Interdict triad and syndicate controlled smuggling activities.
- Detect and prevent extortion.
- Interrupt triad sources of income.

Dangerous Drugs

- Prevent drug trafficking and abuse on outlying islands.
- Deter the abuse of drugs on pleasure craft.

Quick Cash Crime

- Prevent and deter quick cash crime on outlying islands.
- Gain public support to fight quick cash crime.

Public Safety

Public Events

- Ensure public events are conducted safely both at sea and on outlying islands.

Road Safety

- Reduce traffic accidents on outlying islands.

Sea Safety

- Engage the seafaring community to enhance sea safety.

Terrorism

Prevention

- Promote target hardening of ISPS facilities, critical infrastructure and sensitive targets by engaging the cooperation of local stake holders.

Protection

- Protect ISPS facilities, critical infrastructure and sensitive targets in accordance with specific threat assessments.

Preparedness

- Exercise Port Facility Security Plans.

Illegal Immigration

- Deter Il's involvement in illegal activities in the waters of Hong Kong, including fuel smuggling, illegal clam dredging and fishing.

Operational Principles

- Maintain a strong visible uniform police presence
- Provide a fast and effective response to emergencies and major incidents
- Effectively gather intelligence and conduct intelligence-led police operations
- Provide effective and timely investigation into incidents and reports
- Closely engage all sectors of the community to gain their support in preventing crime and maintaining law and order

2012年水警海港警區行動計劃是建基於過往之成功，並配合警隊及水警總區首要行動項目和策略。

首要行動項目

打擊暴力罪案

確保治安

- 遏止涉及青少年、假日遊客及居民的暴力罪案。

家庭暴力

- 及早介入以減少家庭暴力案件。

打擊黑社會、犯罪集團及有組織罪行

- 堵截由黑社會及犯罪集團操控的走私活動。
- 防止及偵破勒索的罪案。
- 打擊黑社會的收入來源。

打擊毒品

- 防止離島區販毒、和吸食危害精神毒品。
- 遏止在遊艇上吸食危害精神毒品。

打擊「搵快錢」罪案

- 預防及遏止在離島區的「搵快錢」罪案。
- 爭取公眾支持打擊「搵快錢」罪案。

提高公眾安全

公眾活動

- 確保海上及離島區的公眾活動有秩序及安全地進行。

道路安全

- 減少離島區的交通意外。

海上安全

- 提高航海人士的安全意識。

加強反恐工作

預防措施

- 透過與本區相關人士合作，提升港口設施、重要基建及可能受到威脅之處所的安全措施及防範意識。

保護措施

- 根據具體明確的威脅評估，採取相應行動，以保護港口設施、重要基建及可能受到威脅的處所。

做好充分準備

- 進行港口設施保安計劃演習。

打擊非法入境活動

- 遏止非法入境者在本港水域進行的非法活動，包括走私燃料、非法挖硯及捕魚。

行動指導原則

- 維持高姿態的軍裝巡邏
- 迅速和有效地應付緊急及重大事故
- 有效地搜集情報和進行以情報為主導的警務行動
- 有效和適時地調查事故及案件舉報
- 與社會各階層保持緊密聯繫，爭取他們對維持治安的支持
