**Report of the CACRC Meeting held on 5 January 2015**

Review of the Building Management Ordinance (Cap.344)

Members gave their opinions on the contents of the public consultation paper on review of the Building Management Ordinance.

Question on Islands District Building Management Workshop 2014

2. Members raised enquiries and gave their opinions on the arrangements of Islands District Building Management Workshop 2014.

Question on Cultural Activities of the Leisure and Cultural Services Department in Islands District

3. Members raised enquiries and gave their opinions on the arrangements and supervision of the cultural activities of the Leisure and Cultural Services Department (LCSD) in the District.

Question on Relocation of HSBC Automatic Teller Machine

4. Members gave their opinions on the location of the HSBC automatic teller machine in Yat Tung Shopping Centre in Tung Chung, and on the written reply of The Link.

Question on Establishment of District Support Centre for Persons with Disabilities in Tung Chung

5. Members raised enquiries and gave their opinions on the proposal to establish a District Support Centre for Persons with Disabilities in Tung Chung.

Question on Arts and Crafts Fair in the Parks of Leisure and Cultural Services Department

6. Members raised enquiries and gave their opinions on the proposal to establish an arts and crafts fair in Tung Chung.

2015/16 Work Plan for Free Entertainment Programme at Islands District by the Leisure and Cultural Services Department

7. Members noted the contents of the free entertainment programme to be held by LCSD in Islands District in 2015/16. A provision of \$478,000 was approved in principle for the organization of the programme, \$42,500 of which was funds for activities to be held in March 2016 and would be paid in the financial year of 2016/17. Proposal of activities to be held from January to March 2016 and their funding arrangements would be submitted to the next term of District Council for confirmation. Members also gave their proposals on the performing organizations and arrangements of free entertainment programme.

2015/2016 Extension Activities of the Leisure and Cultural Services Department in Public Libraries in Islands District

8. Members noted the contents of the extension activities of LCSD in public libraries to be held in Islands District in 2015/16. A provision of \$85,345 was approved in principle for the organization of the programme, \$3,180 of which was funds for activities to be held in March 2016 and would be paid in the financial year of 2016/17. Proposal of activities to be held from January to March 2016 and their funding arrangements would be submitted to the next term of District Council for confirmation.

Recreation and Sports Activities organized by the Leisure and Cultural Services Department in Islands District between April 2015 and March 2016

9. Members noted the contents of the recreational and sports activities to be held by LCSD in Islands District in 2015/16. A provision of \$7,559,930 was approved in principle for the organization of the programme, \$325,520 of which was funds for activities to be held in March 2016 and

would be paid in the financial year of 2016/17. Proposal of activities to be held from January to March 2016 and their funding arrangements would be submitted to the next term of District Council for confirmation.

#### Report on Anti-Corruption Projects in Islands District

10. Members noted the progress of the anti-corruption projects in Islands District, and requested Independent Commission Against Corruption to arrange for its mobile exhibition vehicle to visit Discovery Bay.

#### Reports of Working Groups

##### (i) Vetting Group

11. Members noted the contents of three assessment reports, and that the Vetting Group would follow up on the enquiries raised by organizations on the District Council funds.

##### (ii) CACRC Working Group

12. Members noted the progress of the Islands District Women's Development Program 2014, and that of the CPCE's Cooperation Scheme with District Council 2015-16. They also raised some proposals on the courses of Islands District Women's Development Program to be held in the future.

##### (iii) International Day of Disabled Persons Working Group

13. Members noted the progress of various activities of International Day of Disabled Persons.

#### Reports on the work of the Leisure and Cultural Services Department in Islands District

14. Members noted the progress of the recreational and cultural activities, as well as that of the promotion of public library activities conducted by the LCSD in the Islands District.

15. Members noted that Islands District would take part in the “Green Stalls” of Hong Kong Flower Show 2015, and also noted the progress of “The 5<sup>th</sup> Hong Kong Games”.
