### Report of the CACRC Meeting held on 4 March 2013

Briefing session on Mandatory Building Inspection Scheme and Mandatory Window Inspection Scheme

Members noted the contents of the above schemes and gave opinions on the requirements, procedures, fees and resources of the schemes.

### Question on the Establishment of Job Centre in Tung Chung of Labour Department

2. The Labour Department would establish a job centre in Tung Chung in order to provide a comprehensive employment service for residents. The centre was scheduled to open in 2014. Members gave their views on the services of the centre, the Work Incentive Transport Subsidy Scheme, labour relations and conciliation services, and they hoped that the job centre would be open as soon as possible.

## Question on the Wall of Cheung Chau Pak Tai Temple Playground

3. The Leisure and Cultural Services Department (LCSD) planned to conduct renovation works for the playground in 2013/14, which would include replacement of perimeter fence and installation of energy-absorbing mats at appropriate places.

4. Members noted the contents of the above plan and hoped that the Social Welfare Department would provide better support for victims of domestic violence and the ethnic minorities.
