Report of the DFMC Meeting held on 21 September 2015

Question on request for provision of a temporary soccer pitch in Tung Chung West

Members hoped that the Leisure and Cultural Services Department (LCSD) and the Housing Department would discuss the proposal of reprovisioning of soccer pitch. Members also hoped that the Government would adopt a holistic approach in regards to the long term planning and development of Islands District.

Question on providing additional children's play areas on Sai Tai Road, Cheung Chau

2. The District Lands Office/Islands confirmed that the proposed works site was currently an unleased government land. The children's play area at the said location would be under the management of LCSD after completion of the proposed works project.

Question on management of Discovery Bay beaches (public open area)

3. The Food and Environmental Hygiene Department (FEHD) had reminded the management company of Discovery Bay to monitor the hygiene condition of Tai Pak Wan Beach and ensure that sufficient rubbish bins were provided at the said location and the frequency of rubbish collection service were enhanced.

Question on provision of Hong Kong Government Wi-Fi service at Discovery Bay Community Hall

4. With the assistance of the Office of the Government Chief Information Officer, additional facilities were provided to enhance the Wi-Fi service in the Conference Room of the Discovery Bay Community Hall.

Question on availability and water quality of drinking fountains for use at Discovery Bay Community Hall

5. The Water Supplies Department requested the Architectural Services Department to provide the detailed pipeline plan and information about water pumps. The work was anticipated to be completed within two to four weeks after approval was granted for pipeline modification.

Question on the entrance and exit at Tung Chung Public Library and Municipal Services Building

6. Members hoped that FEHD would actively consider the proposal of widening the pedestrian access.

7. DFMC endorsed the proposals set out in the paper.
