# Welcoming remarks

# I. <u>Election of Chairmen and Vice-Chairmen of the Fifth-Term Islands District Council</u> Committees

- 2. <u>The Chairman</u> said that IDC Secretariat had sent membership lists of the committees under the current term Islands District Council (IDC) and nomination forms for election of the Chairmen and Vice-chairmen of these committees to members. Copies of the membership lists were also tabled for members' perusal. He asked members whether there were any amendments to the lists.
- 3. There were no amendments and further comments.
- (i) <u>Chairman of District Facilities Management Committee (DFMC)</u>
- 4. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Mr WONG Hon-kuen, Ken as the Chairman of DFMC had been received. As there was only one valid nomination, he declared Mr Ken WONG elected Chairman of DFMC.

#### (ii) Vice-Chairman of DFMC

5. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Mr KWONG Koon-wan as the Vice-chairman of DFMC had been received. As there was only one valid nomination, he declared Mr KWONG Koon-wan elected Vice-chairman of DFMC.

# (iii) Chairman of Community Affairs, Culture and Recreation Committee (CACRC)

6. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Ms YU Lai-fan as the Chairlady of CACRC had been received. As there was only one valid nomination, he declared Ms YU Lai-fan elected Chairlady of CACRC.

# (iv) <u>Vice-Chairman of CACRC</u>

- 7. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Ms TSANG Sau-ho, Josephine as the Vice-chairlady of CACRC had been received. As there was only one valid nomination, he declared Ms Josephine TSANG elected Vice-chairlady of CACRC.
- (v) <u>Chairman of Tourism, Agriculture, Fisheries and Environmental Hygiene Committee</u> (TAFEHC)
- 8. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Ms LEE Kwai-chun as the Chairlady of TAFEHC had been received. As there was only one valid nomination, he declared Ms LEE Kwai-chun elected Chairlady of TAFEHC.

## (vi) <u>Vice-Chairman of TAFEHC</u>

9. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Ms FU Hiu-lam, Sammi as the Vice-chairlady of TAFEHC had been received. As there was only one valid nomination, he declared Ms Sammi FU elected Vice-chairlady of TAFEHC.

# (vii) Chairman of Traffic and Transport Committee (TTC)

10. <u>The Chairman</u> said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Mr WONG Man-hon as the Chairman of TTC had been received. As there was only one valid nomination, he declared Mr WONG Man-hon elected Chairman of TTC.

#### (viii) Vice-Chairman of TTC

11. The Chairman said that at the close of nomination at 1:00 p.m. on 18 January 2016, only one nomination form nominating Mr CHEUNG Fu as the Vice-chairman of TTC had been received. As there was only one valid nomination, he declared Mr CHEUNG Fu elected Vice-chairman of TTC.

# II. Appointment of co-opted members for the Fifth Term Islands District Council Committees (Paper IDC 10/2016)
