## Welcoming Remarks

<u>The Chairman</u> welcomed representatives of government departments and organisations as well as Members to the meeting.

2. Members noted that Ms Josephine TSANG and Mr Eric KWOK were unable to attend the meeting due to other commitments.

## I. Confirmation of Minutes of Previous Meeting held on 8 November 2021

- 3. <u>The Chairman</u> said that the above minutes had incorporated the amendments proposed by government departments and organisations and had been distributed to Members for perusal prior to the meeting.
- 4. The captioned minutes were confirmed unanimously without further amendments proposed by Members.

#### II. Reports by Working Groups

- (i) <u>Community Affairs, Culture and Recreation Committee (CACRC) Activities</u> <u>Working Group</u>
- 5. The Working Group originally planned to organise the "Islands District Cantonese Opera Show" and the "Islands District Council Presents: Golden Songs Concert" during the period from November 2021 to February 2022. However, both activities were cancelled due to unavailability of the venues concerned on the respective activity dates.
- 6. The report of the Working Group had been tabled at the meeting for Members' perusal.

# (ii) <u>Islands District International Day of Disabled Persons Working Group</u>

- 7. The Working Group had held the "Ocean Park Fun Month" on 1 and 5-7 November 2021 and the Free Transportation Day for Disabled Persons on 14 November 2021.
- 8. The report of the Working Group had been tabled at the meeting for Members' perusal.
- 9. Members unanimously endorsed the above two working group reports.

(Mr HO Chun-fai and Mr HO Siu-kei joined the meeting at around 2:03 p.m.)

# III. Matters concerning the Working Groups under CACRC in 2022-2023

- 10. The Chairman said that the Islands District Council (IDC) had held the election of chairmen and vice-chairmen of various committees under the IDC (2022-2023) at the full council meeting on 13 December 2021. The IDC also agreed that the chairman of each committee would preside over the election of convenors and vice-convenors of the working groups under the committee as necessary. As the membership of the working groups had just been finalised, the Chairman suggested that, subject to Members' agreement, the three Working Groups under CACRC should follow the past practice and elect the respective convenors and vice-convenors at the first working group meetings to be held.
- 11. Members unanimously endorsed the above proposal.

#### IV. Any Other Business

12. Mr WONG Kin-sun said that since 2015, the Community Relations Department of the Independent Commission Against Corruption (ICAC) had rolled out a territory-wide anti-corruption programme entitled "All for Integrity" comprising an array of activities to sustain and pass on the probity culture, thereby reaching out to the general public for making a concerted effort in upholding the core values of integrity and observance of law as well as deepening the probity culture of Hong Kong. Signature Event of "All for Integrity" (the Event) this year would be held at Tai Kwun in Central from the afternoon of 25 February to the evening of 27 February 2022. Based on the concept of "Journey for Integrity", the Event would consist of a series of activities which would provide an occasion for the participants to personally engage in the progress of anti-corruption in Hong Kong, have reflection on the anti-corruption history of Hong Kong and a better understanding on the scourge of corruption as well as the rule of law under Hong Kong's legal system; ultimately it could consolidate the public support for the work of anti-corruption. The Event would showcase the history and progress of the anti-corruption work in Hong Kong, the models of evidence involved in some major corruption cases, and featured exhibitions such as promotional

and educational works, posters and so on since the 1970s. The Event would also set up an interactive games zone, including scenes of evidence collection presented in the form of virtual reality, interactive games and photo props for taking snapshots, etc. Visitors could participate in an activity "Integriteering" themed on anti-corruption and integrity, and obtain souvenirs after identifying various checkpoints and completing the corresponding missions throughout Tai Kwun. Members were invited to refer to the information sheet tabled at the meeting for the details of the activities. Moreover, Members were welcomed to visit the activity venue and assist in promoting the activities to residents. All participants of the activities except exempted persons were required to comply with the control and prevention measures against the coronavirus disease 2019 epidemic adopted by Tai Kwun, such as undergoing body temperature screening, wearing a mask and using the mobile app "LeaveHomeSafe". Members who were interested in participating in the activities or had any enquiries were welcomed to contact him.

(Post-meeting note of ICAC: To take into account the recent development of the epidemic and tie in with the updated Government's epidemic prevention and control policies, the ICAC had decided to postpone the Event and the activity date would be announced in due course.)

## V. <u>Date of Next Meeting</u>

13. There being no other business, the meeting was adjourned at 2:10 p.m. The next meeting would be held at 2:00 p.m. on 7 March 2022 (Monday).
