Public Housing Developments at Tung Chung Area 103 (TC 103) and Tung Chung Area 109 (TC 109)

PURPOSE

1. This Paper aims to brief the Islands District Council (IsDC) on the proposal of the Hong Kong Housing Authority (HA) for two public housing developments at TC 103 and TC 109 and listen to the views of Members.

BACKGROUND

2. Civil Engineering and Development Department is carrying out reclamation and site formation works at Tung Chung Extension Area. The housing sites of TC 103 & TC 109 are targeted to be handed over to HA at end of 2020 for public housing developments (see **Annex 1** for the Location Plan).

PROPOSED DEVELOPMENT

3. The development parameters of the two proposed public housing developments are summarized as follows:
