



## Lantau District Action Plan 2020

### Operational Priorities

#### **Violent Crime**

- ❖ Maintain a strong and highly visible police presence at key locations to deter violent crime.
- ❖ Conduct intelligence-led operations against street gangs, particularly those involving youths.
- ❖ Ensure professional and sensitive case handling when investigating violent crime, particularly those cases involving vulnerable persons.

#### **Triads, Syndicated and Organised Crime**

- ❖ Take proactive enforcement action against debt-collection agencies who threaten life and property.

#### **Drug and Substance Abuse by Students and Youths**

- ❖ Enforce a multi-agency and community-based approach to prevent drug and substance abuse by students and youths.

#### **Quick Case Crime & Cyber / Technology Crime**

- ❖ Promote crime prevention and raise awareness to prevent quick cash crime, particularly pickpocket and all forms of deception and cyber technology crime.
- ❖ Strengthen community and stakeholder support to interdict shop and miscellaneous theft.

#### **Burglary**

- ❖ Effectively task and deploy police resources to reduce burglaries including theft from construction site and reassure local communities.
- ❖ Promote the installation of CCTV and other physical alarm systems.

#### **Street Management**

- ❖ Implement consistent and determined enforcement action to deter Street Gambling, Illegal Parking and other anti-social behaviours.

### Operational Priorities

#### **Public Safety**

##### **(a) HZMB HKBCF and Public Transport Operators**

- ❖ Secure effective communication and liaison with the operators and key strategic partners to protect the integrity and security of HKBCF and public transport infrastructure.

##### **(b) Public Disorder**

- ❖ Enhance preparedness, readiness and capability in dealing with all scales of public disorder.
- ❖ Provide rapid and effective response to all scales of public disorder.
- ❖ Enhance cooperation with other stakeholders, and enlist their support in maintaining and restoring public order and safety during and after any incidents of public disorder.

#### **Public Events**

- ❖ Strengthen public trust, understanding of and support to, the roles and responsibilities of the Police in maintaining public order and safety for the community.
- ❖ Ensure good public order and safety during public events through proactive engagement with relevant stakeholders, effective planning and execution.
- ❖ Strengthen intelligence-led operations against groups and / or individuals causing or threatening violence during public events.

##### **(c) Road Safety**

- ❖ Implement a multi-agency approach to promote road safety and reduce fatal and serious traffic accidents particularly those involving the use of banned Electric Mobility Devices, cyclists, and elderly pedestrians.

##### **(d) Major Incidents and Disasters**

- ❖ Strengthen resilience and ensure a coordinated, fast and effective response to major incidents and disasters.

## **Terrorism**

- ❖ Build capacity and enhance operational readiness through regular training and multi-agency exercises.
- ❖ Secure support and collaboration with the operators of critical infrastructure and other key location including HKZMB, HK Disney, MTRC, and Ngong Ping 360 to enhance protection, reduce vulnerability and strengthen multi-agency response capability.
- ❖ Enhance recovery capabilities to ensure rapid restoration of normality and community confidence following a terrorist incident.

## District Projects

### **Lantau Eyes:**

- ❖ Working in partnership with District Fight Crime Committee, Rural Committees, Village Representatives and other key stakeholders to develop a sense of shared ownership in tackling policing issues.
- ❖ Build a digital platform for dissemination of crime prevention information across the wider community.

### **Harmony:**

- ❖ Engage and educate local residents, tourists and visitors to Lantau of local crime trends and promote crime prevention activities through various digital platforms.

### **Fast Marker:**

- ❖ Strengthen close partnerships with Building Management Companies and other stakeholders to tackle seasonal crime and anti-social behaviours.
- ❖ Utilize digital platforms and social media to share crime prevention and public safety bulletins.

### **Vision Possible:**

- ❖ Provide a platform for young people to participate in sports, engage in healthy-lifestyle activities, and develop core leadership skills.
