有關東薈城電單車泊位的提問

方龍飛議員通知本會，在 2020 年 11 月 16 日舉行的交通及運輸委員會會議上，他將會提出以下提問：

“ 本人日前收到一封來自少數族裔人士的聯署信(見附圖 1)，表示他們從事電單車外賣速遞工作，但東薈城沒有可供短暫停泊的電單車泊位，導致他們被迫違泊而收到警方告票，並需繳付罰款。他們只靠外賣速遞賺取每日 400 至 500 元的微薄薪金，實難以負擔。

就此，本人請運輸署及東薈城管理公司派代表出席會議，回應以下提問：

1. 東薈城管理公司可否在東薈城提供免費的短暫電單車泊位，供外賣速遞員短暫停泊？
2. 運輸署可否考慮將美東街迴旋處部分位置劃作臨時短暫電單車泊位(見附圖 2 及 3)？ ”

Letter

Dear Sir/Madam,

We are writing this letter to inform you that, we are the Foodpanda riders of Tung Chung area, we request to the person in-charge of car park of city-gate to allow us to have at least 20 minutes to park our scoter for pick up the food order from the city-gate's restaurants as we face few issue for parking.

We have never complained about anything until now, however in the past few weeks we been facing a few problems, as we were not allowed to park the scoter near the city-gate as security guards threatened us that " they will toe away the scoter" if we park the scoter near the city-gate. Therefore, we park our scoter on one side of the Tat Tung Road and cross the road to get into the city-gate, since there is a lot of traffic on the road we find it very difficult to cross it and it is also quite risky. Plus the police give us the ticket for parking at the road side without a warning which they think we parked the scoter for other reason, we really do not know who to seek for help on this as police also doing their duty. We believe that you are aware of the current financial status, we are working hard and delivering foods to the people. Yes, we do get paid for deliveries but at the same time if we have to pay for police tickets or parking it does effect us quite badly as we parked our scoter for food pick up not for some other reason.

For your reference, Foodpanda provide us 15 minutes for normal order pick up but when the order is quite big or if the restaurant itself is busy (at most time restaurants are busy) it does take longer time to prepare the food, however we only request for 20 minutes as we will manage if the order takes more then 15 minutes , if the security guards inspect the scoter have been parked for longer time then they have all the rights to take the necessary steps.

For our safety and smooth deliveries please do consider on the above request and get back to us as earliest as possible. If you have any issue on this matter kindly contact the person at 6464
