

Lantau District Operational Priorities 2025

National Security

- Enhance frontline officers' skill and knowledge of their roles and responsibilities, and intelligence gathering capability in safeguarding national security.
- Enhance communication and cooperation with relevant community stakeholders, and enlist
 public trust and support for the roles and responsibilities of Police in safeguarding national
 security through raising the public awareness of national security.

Violent Crime

- Ensure effective deployment of resources to deter violent crime, particularly at high-risk locations.
- Strengthen intelligence-led operations against street gangs and their activities, particularly those involving youths.
- Ensure professional and sensitive case handling when investigating violent crime, particularly those cases involving vulnerable persons.

Triads, Syndicated and Organised Crime

- Target triad personalities and activities, in particular those exploiting youths, by mounting intelligence-led operations.
- Take proactive enforcement action against debt-collection agencies who threaten life and property, in particular those who seek to exploit youths.

Drugs and Substance Abuse by Students and Youths

 Promote awareness and prevent the abuse of drugs and substance by students and youths through a multi-agency and community-based approach.

Deception and Quick Cash Crime

- Enhance public awareness and secure support through public-private partnership and multiagency approach to prevent deception and quick cash crime, in particular shop and miscellaneous theft.
- Ensure strategic deployment of resources to blackspots of quick cash crime.

Cyber Security and Technology Crime

• Enhance public awareness of cyber security and technology crime as well as the risks and liabilities associated with the Internet and social media through a multi-agency approach.

Burglary / Smuggling

• Effectively task and deploy Police resources to deter burglary and smuggling, and reassure local communities.

Public Safety

(a) Public Disorder

- Strengthen public awareness about the importance of being law abiding through cooperation with different stakeholders, including government bureaux/departments, schools and nongovernmental organisations (NGOs).
- Enhance Police preparedness, readiness and capability in dealing with all scales of public disorder.
- Provide rapid and effective response to all scales of public disorder.
- Enhance cooperation with different stakeholders including government bureaux/departments, private entities, schools and NGOs, and enlist their support in maintaining and restoring public order and safety during and after any incidents of public disorder.

(b) Public Events

- Strengthen public trust, understanding of, and support for, the roles and responsibilities of Police in maintaining national security, public order and safety for the community, in particular among youths.
- Engage organisers, the media and other stakeholders of public events to enhance mutual understanding and enlist their support.
- Ensure public events, sports, entertainment and celebration events are held in a safe and orderly manner, through proactive engagement and coordination with relevant stakeholders, including event organisers, venue operators and different government bureaux/ departments for effective planning and execution.

(c) Road Safety

- Reduce fatal and serious traffic accidents, particularly those involving public transport, cycling, motorcycles and goods vehicles, through a multi-agency approach.
- Promote safe cycling, and pedestrian safety with particular emphasis on elderly.
- Ensure smooth traffic flow through application of the Selected Traffic Enforcement Priorities (STEP) and the use of technology.

(d) Major Incidents and Extreme Weather

- Ensure preparedness for major incidents and extreme weather situation by conducting regular multi-agency exercises to test and improve contingency plans.
- Provide a professional, coordinated and rapid response through cooperation among government bureaux/departments and engagement with stakeholders community-wide.

Terrorism

- Strengthen intelligence gathering and counter-terrorism capability to deter and prevent terrorist activities through the collaboration with government bureaux/departments and other agencies.
- Enhance public participation and preparedness against terrorist or violent attacks by collaboration with the operators of critical infrastructure and other identified specific locations to enhance protection, reduce vulnerability and strengthen multi-agency response capability.

Policing of the 15th National Games

- Ensure the 15th National Games and the related events are held in a safe, orderly and secure manner.
- Adopt a multi-agency approach to provide an effective operational strategy and facilitate the
 effective deployment of resources to manage the Games.
