Welcome Remarks

<u>The Chairman</u> said a quorum was present and the sixth meeting of the Community Involvement, Culture and Recreation Committee (CICRC) in 2024 commenced officially. He welcomed all Members and departmental representatives to the meeting, in particular those who attended the CICRC meeting for the first time:

- Ms Amy YUEN, Assistant Social Work Officer, Sai Kung Integrated Family Service Centre, Social Welfare Department (SWD); and
- Ms Iris WONG, Senior Manager (Youth Service), and Ms Rebecca LAM, Social Worker, of the Artiste Training Alumni Association Jockey Club Tseung Kwan O Youth Square, Hong Kong Family Welfare Society (HKFWS).

I. <u>Confirmation of Minutes of the 5th CICRC Meeting in 2024 held on 17 September 2024</u>

2. <u>The Chairman</u> said the Secretariat had not received any proposed amendment before the meeting. As there was no proposed amendment at the meeting either, the Chairman declared that the above minutes were confirmed.

II. Report Items

- (A) <u>Introduction of Social Welfare Services/District Collaboration Projects in Sai Kung/Tseung Kwan O Hong Kong Family Welfare Society</u>
- 3. <u>Ms Iris WONG and Ms Rebecca LAM of HKFWS</u> introduced the projects with the presentation slides.
- 4. Members' views and enquiries were summarised as follows:
 - They enquired about the ratio of staff and social workers of HKFWS to its service users.
 - They suggested that HKFWS should work with the Care Teams of Sai Kung District to provide training services for volunteers. HKFWS should also collaborate with the ward offices of District Council members and district organisations such as Sai Kung and Tseung Kwan O Women's Association to co-organise activities and courses.
- 5. <u>Ms Iris WONG, Senior Manager (Youth Service), Artiste Training Alumni Association Jockey Club Tseung Kwan O Youth Square, HKFWS</u> gave consolidated responses as follows:
 - According to SWD's planning standards, there would be one Integrated Children and Youth Services Centre (ICYSC) providing services for every 12 000 children and youth aged 6 to 24.
 - To align with the development and needs of the community, such as concerns about mental health and emotional problems, as well as increasingly complicated family issues, the Centre would provide more in-depth services for the youth and their families in need.
 - There were around 40 staff members in the Centre, including eight social workers in the establishment of ICYSC, school-based social workers, social workers for other service projects, and event staff. The Centre served

- children and youth from both within and outside the district through community-based, school-based and project-based services. The Centre would fulfill the requirements of SWD's Funding and Service Agreements while utilising resources in a flexible manner.
- She welcomed Members' suggestions and looked forward to more district collaboration projects.

- 6. Members noted the paper.
- (C) Report on the Half-yearly Implementation Progress of Community Involvement Programme by the Sai Kung District Office (April to September 2024) (SKDC(CICRC) Paper No. 43/24)
- 7. Members noted the paper.
- (D) Report on Organisation of Recreation and Sports Programmes from April to September 2024 in Sai Kung District by the Leisure and Cultural Services Department (SKDC(CICRC) Paper No. 44/24)
- 8. Members noted the paper.
- 9. Ms Jenny LAI, Deputy District Leisure Manager (District Support) Sai Kung, Leisure and Cultural Services Department (LCSD) said the Sai Kung District Leisure Services Office would organise two greening activities at the Hong Kong Velodrome and the Hong Kong Velodrome Park on 8 December 2024 and 18 January 2025 respectively. The content of the activities included teaching of knowledge about trees and horticulture. E-mail invitations for the activities had been sent to the 25 Community Green Ambassadors of the Sai Kung District Council (SKDC) on 7 November. Ambassadors were welcomed to enroll and join the activities.
- (E) Report on the Cultural Programmes in Sai Kung District during August to December 2024 by the Leisure and Cultural Services Department (SKDC(CICRC) Paper No. 45/24)
- 10. Members noted the paper.
- 11. Members suggested organising more activities at the Tseung Kwan O Waterfront Park. They also proposed continuing to organise harmonica activities.
- 12. <u>Ms Stella OR, Senior Manager (New Territories East) Promotion, LCSD</u> responded that she would relay Members' views to the Programmes Offices, so as to organise more suitable activities for the residents of Tseung Kwan O or Sai Kung.

- (F) Report on the Extension Activities of the Public Libraries in Sai Kung District by the Leisure and Cultural Services Department (SKDC(CICRC) Paper No. 46/24)
- 13. Members noted the paper.

III. Motions Raised by Members

- (A) The two motions raised by Members
- (1) Expedite the construction of recreational facilities in the district: The sports centre in Area 86 (LOHAS Park), the water sports centre in Area 77 (Tseung Kwan O waterfront), as well as the sports centre and town plaza in Sai Kung Area 4 (Sai Kung town centre)
 (SKDC(CICRC) Paper No. 47/24)
- 14. The Chairman said the motion was moved by Ms Christine FONG and seconded by Mr WANG Wen, Mr LI Tin-chi, Mr Philip LI, Mr CHAU Ka-lok, Mr YAU Ho-lun, Ms SZE Pan-pan, Ms WU Suet-lin, Mr CHEUNG Chin-pang, Mr CHEUNG Man-tim, Mr CHONG Yuen-tung, Mr CHAN Kwong-fai, Mr LAM Chun-ka, Ms KI Lai-mei, Mr CHENG Yu-hei, Mr WONG Yuen-hong and Mr Chris CHEUNG.
- 15. Members noted the written reply from LCSD (SKDC(CICRC) Paper No. 49/24).
- 16. Members' views and enquiries were summarised as follows:
 - They asked about the progress and timetable of the sports centre in Area 86, and whether SKDC would be further consulted early next year. They also suggested providing short-term recreational and sports facilities to meet residents' needs before the completion of the sports centre.
 - They enquired about the construction progress of the public vehicle park and town park in Area 66. They also enquired the timeline of submitting the funding application to the Finance Committee of the Legislative Council.
 - They suggested carrying out the construction of the water sports centre in Area 77 and the reclamation works in Area 132 simultaneously to reduce the impact on the environment.
 - They asked about the details of the work expected to be conducted in 2025 and the design for the water sports centre in Area 77.
- 17. <u>Ms Jenny LAI, Deputy District Leisure Manager (District Support) Sai Kung, LCSD</u> gave consolidated responses as follows:
 - At present, the works projects in Area 86, Area 77 and Area 4 were being followed up by the Planning Section of LCSD. Regarding the progress and preliminary design of the above projects, as well as the suggestion to carry out

- the reclamation works in Area 132 simultaneously, the Planning Section would provide relevant information and replies after the meeting.
- The construction project of the public vehicle park and town park in Area 66 was currently led by the Transport Department (TD). LCSD did not have relevant information at the moment.
- 18. There being no objection from Members, the Chairman declared that the above motion was passed. He then asked LCSD and TD to follow up the matter.
- 19. <u>The Chairman</u> suggested deleting the above item at the next meeting.
- (2) Suggest organising roving exhibitions of "Quby" statues in other areas of Tseung Kwan O and setting up different photo-taking spots to promote local economic and tourism development (SKDC(CICRC) Paper No. 48/24)
- 20. <u>The Chairman</u> said the motion was moved by Ms KAN Tung-tung and seconded by Mr WANG Wen, Mr LI Tin-chi, Mr CHAU Ka-lok, Mr YAU Ho-lun, Mr Chris CHEUNG, Ms SZE Pan-pan, Ms WU Suet-lin, Mr CHAN Kuen-kwan, Mr CHEUNG Man-tim, Mr CHONG Yuen-tung, Mr LAM Chun-ka, Mr Philip LI, Mr CHENG Yuhei, Mr WONG Wang-to, Mr TSANG Kwok-ka, Mr WAN Kai-ming, Mr LAU Kai-hong and Ms Christine FONG.
- 21. Members noted the written reply from the Sai Kung District Office (SKDO) (SKDC(CICRC) Paper No. 50/24).
- 22. Members' views were summarised as follows:
 - They suggested setting up distinctive photo-taking spots and organising roving exhibitions of "Quby" and the "Sai Kung Cat Neighbours Mural" in different places of the district. They also suggested collaborating with shops to attract more visitors to Sai Kung District and boost local economic development.
 - If there were any changes, additions or reductions made to the photo-taking spots in the future, Members could be notified in advance to facilitate publicity effort.
- 23. <u>Miss LAM I-ching, Assistant District Officer (Sai Kung)1, SKDO</u> gave consolidated responses as follows:
 - The activities organised by the Working Group on Boosting Local Economy, including the Sai Kung Tin Hau Festival in May and the 'WE "WA!" Sai Kung' Halloween Celebration Event in October this year, had incorporated various elements to help shops attract more footfall.
 - SKDO would continue to promote existing landmarks in the district with a view to attracting visitors from both within and outside the district.

Meanwhile, subject to available resources and venue feasibility, SKDO would proactively consider setting up new photo-taking spots in other locations of the district such as Hang Hau or Tiu Keng Leng to boost the local economy.

- 24. There being no objection from Members, the Chairman declared that the above motion was passed and asked SKDO to follow up the matter.
- 25. The Chairman suggested deleting the above item at the next meeting.
