

**Progress Report of Sai Kung District Council
Food, Environment and Hygiene Committee**

The second meeting (2024) of the Sai Kung District Council Food, Environment and Hygiene Committee (FEHC) was held on 14 March. The major issues discussed at the meeting were summarised as follows:

Food and Environmental Hygiene Department's Anti-rodent Campaign 2024 (Phase I) in Sai Kung District

Suggestion for the Water Supplies Department to improve pipework design and follow up on the pipe leakage problem in the newly-designed water supply system which leads to increased difficulties in repairing the leaking water pipes

9. FEHC passed the above motion, noted the written reply from the Water Supplies Department (WSD), and asked WSD to follow up the matter.

10. FEHC agreed to delete the above item at the next meeting.

Suggest providing a GREEN@COMMUNITY recycling store at a fixed location in LOHAS Park to facilitate residents' recycling and promote municipal solid waste charging

11. FEHC passed the above motion, noted the written reply from the Environmental Protection Department (EPD), and asked EPD to follow up the matter.

12. FEHC agreed to delete the above item at the next meeting.

Item referred by the full Sai Kung District Council Meeting: Summary of District Consultation on the “Issues of Concern to Sai Kung District – Environmental Hygiene” (Problems of mosquitoes/biting midges and rodents)

13. FEHC noted the written replies from FEHD, the Highways Department, DLO/SK, the Leisure and Cultural Services Department (LCSD) and the Housing Department, and asked FEHD, DLO/SK and LCSD to follow up the matter.
