

**Progress Report of Sai Kung District Council**  
**Food, Environment and Hygiene Committee**

The fourth meeting (2024) of the Sai Kung District Council Food, Environment and Hygiene Committee (FEHC) was held on 11 July. The major issues discussed at the meeting were summarised as follows:

Food and Environmental Hygiene Department's Anti-rodent Campaign 2024 (Phase II) in Sai Kung District

2. FEHC noted the above report.

Item referred by the Sai Kung District Council: Summary of District Consultation on the "Issues of Concern to Sai Kung District – Environmental Hygiene" (Wild boars and illegal parking of bicycles)

3. FEHC noted the written replies from the Agriculture, Fisheries and Conservation Department (AFCD), the Food and Environmental Hygiene Department (FEHD), the District Lands Office, Sai Kung (DLO/SK), the Transport Department (TD) and the Sai Kung District Office (SKDO), and asked AFCD and TD to provide supplementary information in response to Members' enquiries.

Request the Environmental Protection Department to exercise stringent control over the vetting and approval process of construction noise permits for engineering works, carry out more random checks and monitor the traffic noise from the tunnel next to Ocean Shores, and ask the departments concerned to resolve the noise problem at the relevant road section in the long run

4. FEHC noted the written reply from the Environmental Protection Department (EPD) and asked EPD to follow up the matter.

Request for improvement to the telephone appointment service of the institutions under the Hospital Authority

5. FEHC noted the written reply from the Hospital Authority (HA) and asked HA to provide supplementary information regarding Members' enquiries.

Statistics on Environmental Hygiene Service and Itinerant Hawkers in Sai Kung District

10. FEHC passed the above motion, noted the written replies from the Housing Department (HD) and the Tobacco and Alcohol Control Office (TACO) of the Department of Health (DH), and asked HD and TACO of DH to follow up the matter.

Request for improving the method of distributing discs at Mona Fong Dental Clinic and increasing the quota for general public sessions offered by government dental clinics as soon as possible

12. FEHC passed the above motion, noted the written reply from DH, and asked DH to follow up the matter.

Request for stepping up efforts against indiscriminate placement of skips in the vicinity of Wan Po Road

14. FEHC passed the above motion, noted the written replies from EPD, DLO/SK, FEHD, the Hong Kong Police Force (HKPF) and SKDO, and asked EPD, DLO/SK, FEHD, HKPF and SKDO to follow up the matter.
