

**Progress Report of Sai Kung District Council
Community Involvement, Culture and Recreation Committee**

The fourth meeting (2024) of the Sai Kung District Council Community Involvement, Culture and Recreation Committee (CICRC) was held on 16 July. The major issues discussed at the meeting were summarised as follows:

Report on the Cultural Programmes in Sai Kung District during April to August 2024 by the Leisure and Cultural Services Department

Report on the Extension Activities of the Public Libraries in Sai Kung District by the Leisure and Cultural Services Department

Make optimal use of public space to promote economic growth in Sai Kung District, enhance its vibrancy and offer more development opportunities for youth in Hong Kong

6. CICRC passed the above motion, requested LCSD and PlanD to follow up the matter, and asked the Secretariat to relay Members’ views to the Culture, Sports and Tourism Bureau in writing.
7. CICRC agreed to delete the above item at the next meeting.

Request for allocating additional resources to tackle the problem of young night drifters in the district

8. CICRC passed the above motion, noted the written replies from LCSD, the Social Welfare Department (SWD) and the Hong Kong Police Force (HKPF), and asked LCSD, SWD and HKPF to follow up Members' views.

CICRC asked the representatives of SWD to convey to the Hong Kong Federation of Youth Groups and the Hong Kong Young Women's Christian Association the Sai Kung District Council's interest in visiting the activities held for the young night drifters, and agreed to delete the above item at the next meeting.

Suggest enhancing the facilities in shopping malls in the district by providing more seats and improving the seat design

10. CICRC passed the above motion, noted the written reply from the Link Asset Management Limited (LINK) and asked LINK to follow up Members' views.

11. CICRC agreed to reflect Members' views to the relevant management company of shopping malls in writing and delete the above item at the next meeting.

Request for holding Olympic-themed publicity activities in the district

12. CICRC passed the above motion, noted the written replies from LCSD and the Sai Kung District Office (SKDO), and asked LCSD and SKDO to follow up Members' views.

13. CICRC agreed to delete the above item at the next meeting.

Request for enhancing the promotion of library collections on patriotism to celebrate the 75th anniversary of the founding of the People's Republic of China

14. CICRC passed the above motion, noted the written reply from LCSD, and asked LCSD to follow up Members' views.
