

**Progress Report of Sai Kung District Council  
Food, Environment and Hygiene Committee**

The fourth meeting (2025) of the Sai Kung District Council Food, Environment and Hygiene Committee (FEHC) was held on 17 July. The major issues discussed at the meeting were summarised as follows:

Second Phase of Anti-rodent Campaign 2025 in Sai Kung District

Request the Food and Environmental Hygiene Department to step up rodent control efforts in Tseung Kwan O (particularly Tseung Kwan O North) to address the severe rodent infestation problem

2. FEHC agreed that the above items should be discussed together.
3. FEHC noted the above report and the written reply from the Food and Environmental Hygiene Department (FEHD), and asked FEHD to follow up Members' views.
4. FEHC agreed to delete the above discussion item at the next meeting.

Arrangement of Lunar New Year Fair in Sai Kung District

5. FEHC noted the above report and asked FEHD and the Sai Kung District Office (SKDO) to follow up Members' views.

Face-lifting Work of Ma Yau Tong Public Toilet

6. FEHC noted the above report and asked FEHD, the Civil Engineering and Development Department (CEDD), SKDO and the Highways Department (HyD) to follow up Members' views.

Third Phase of Anti-mosquito Campaign 2025 in Sai Kung District

Request the Food and Environmental Hygiene Department to step up mosquito and biting midge control efforts in Sai Kung (particularly Tseung Kwan O North) to address the worsening mosquito infestation problem

7. FEHC agreed that the above items should be discussed together.
8. FEHC noted the above report and the written reply from FEHD, and asked FEHD, the Leisure and Cultural Services Department (LCSD) and HyD to follow up Members' views.

12. FEHC noted the above report and asked CEDD, the Environmental Protection Department, FEHD, HyD and the Traffic and Transport Committee to follow up Members' views.

Statistics on Enforcement Actions by the Agriculture, Fisheries and Conservation Department Against Illegal Feeding of Wild Pigeons in Sai Kung District

13. FEHC noted the above report.

Suggest increasing the number of service units under the Community Dental Support Programme in Sai Kung District to better safeguard the dental health of elderly residents

14. FEHC noted the written reply from the Department of Health (DH) and asked DH to follow up Members' views.

15. FEHC agreed to delete the above discussion item at the next meeting.

Suggest reviewing and simplifying the Application for Outside Seating Accommodation (OSA) licensing process for Sai Kung restaurants

16. FEHC noted the written replies from the District Lands Office, Sai Kung, the Buildings Department, FEHD and the Fire Services Department, and asked FEHD to follow up Members' views.

17. FEHC agreed to delete the above discussion item at the next meeting.

Suggest the relevant government departments step up efforts in addressing the issue of cotton tree fluff dispersal in the community, with Sai Kung as a pilot area, to alleviate the nuisance

18. FEHC noted the written replies from FEHD and LCSD, and asked LCSD to follow up Members' views.

19. FEHC agreed to delete the above discussion item at the next meeting.
