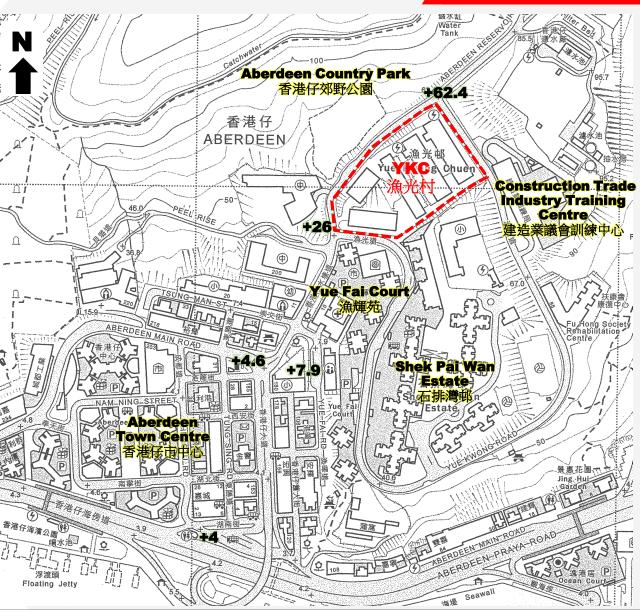

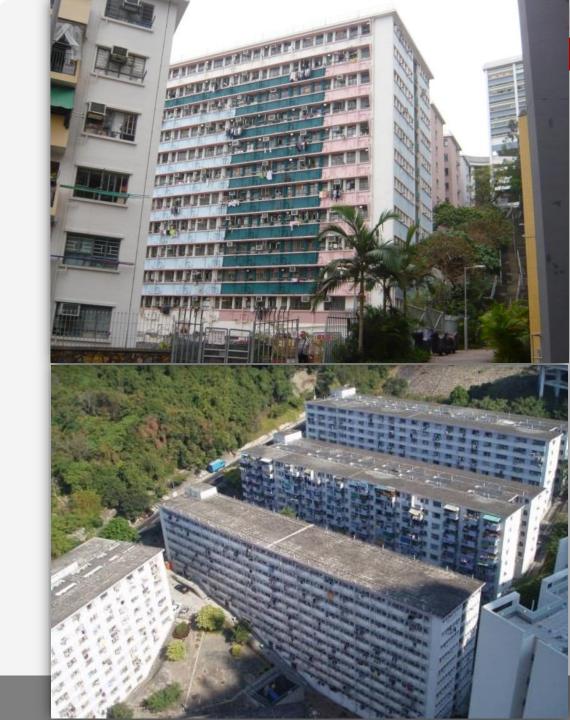
漁光村位置圖和附近環境 Yue Kwong Chuen (YKC) Location Plan and Surrounding Environment



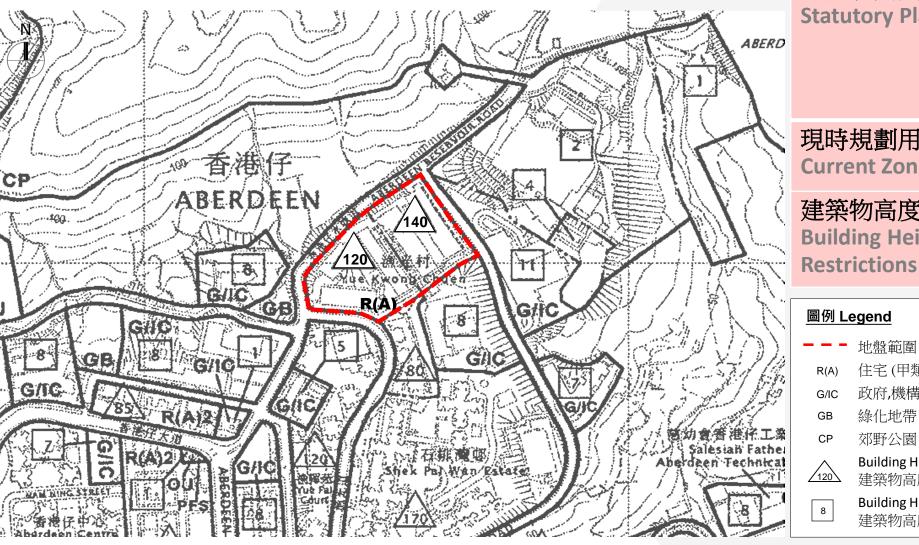


漁光村重建 Redevelopment of YKC

 YKC, built in the 1960s with over 50 years of history, is in need of redevelopment
- 重建漁光村能釋出並善用該地段的發展潛力,提供更多資助 房屋單位以回應社會對住屋的殷切需要
 - Redevelopment of YKC will release development potentials to provide more subsidised housing in response to the keen housing needs of the society
- 重建計劃亦會優化單位設計以應對老化人口的需要,及提供 社會福利設施以應對香港仔以至南區居民的需要
 - Redevelopment will also enhance unit design to meet the needs of the aging population, and provide social welfare facilities to serve the local community in Aberdeen and the wider Southern District

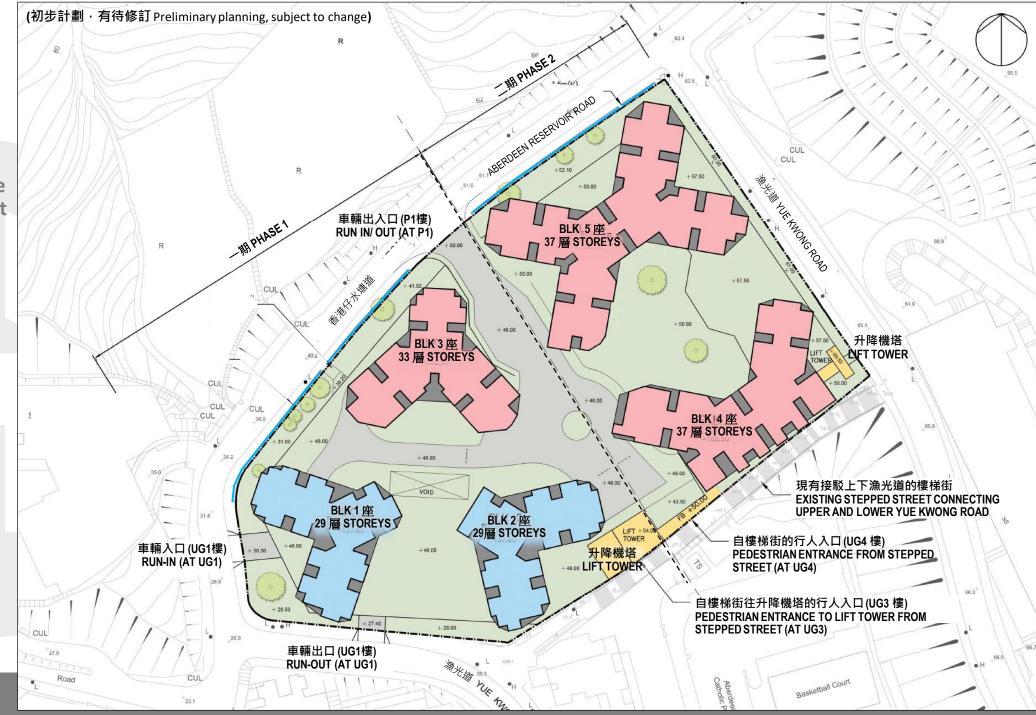

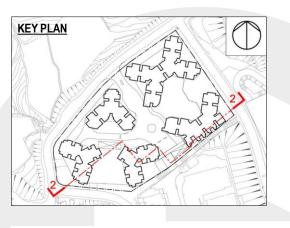

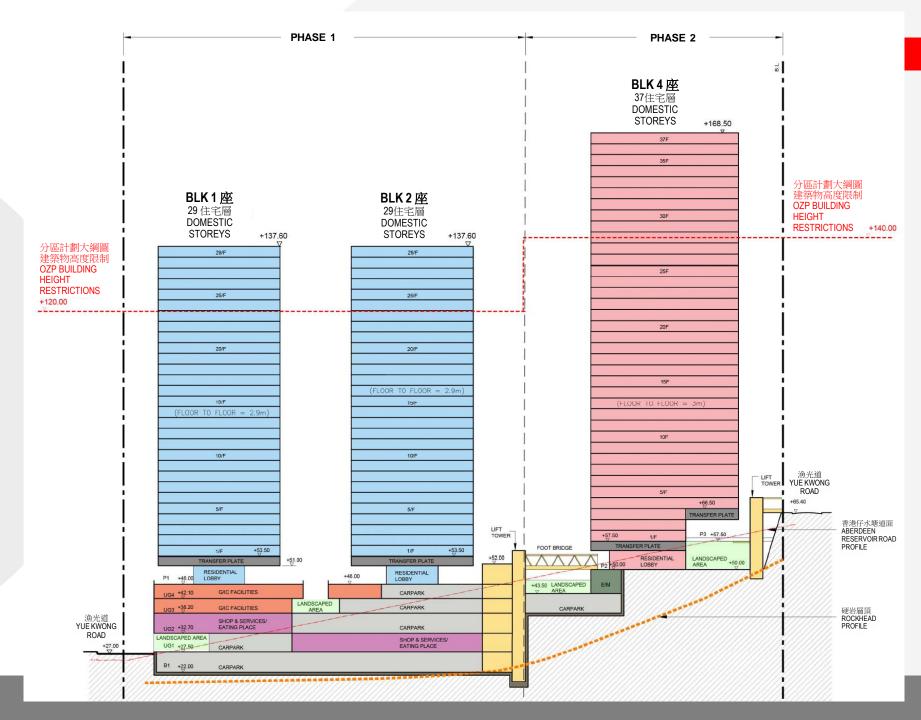
Section Plan of the Proposed Redevelopment

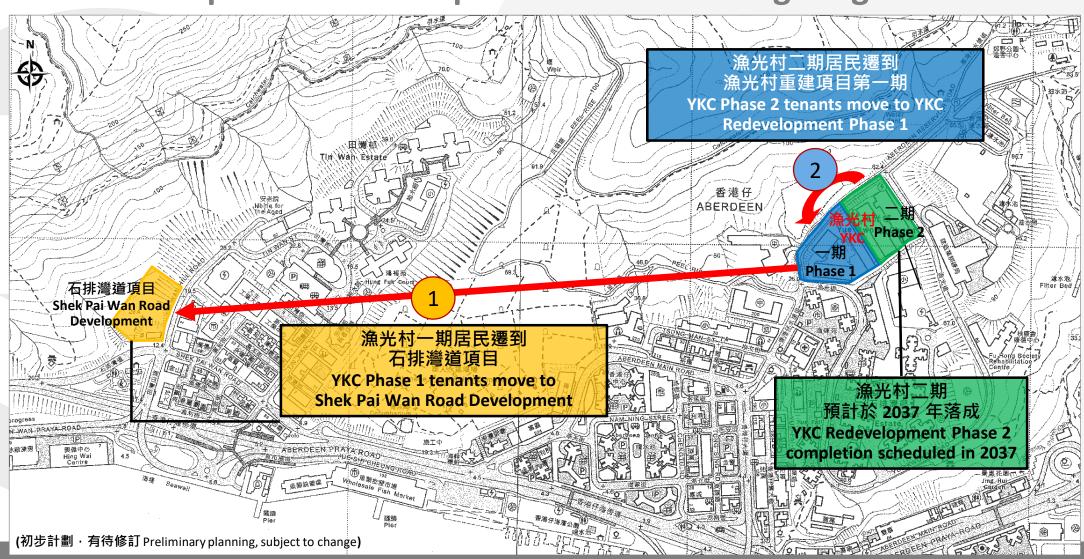

 Provides social welfare facilities to cater for the needs of the community
- 改善漁光村現有租戶的生活條件
 Improves the living condition of the existing YKC tenants

地區及公眾諮詢 Local and Public Consultation

房協過去曾於2013年9月及2016年3月出席南區區議會轄下的事務委員會會議,就漁光村重建及石排灣道出租屋邨發展項目諮詢委員意見,兩者均獲得多位委員支持。

HKHS attended the SDC Committee meetings in September 2013 and March 2016 to collect views towards the redevelopment of YKC and the Shek Pai Wan Road development project. Both were supported by most Members at the meetings.

就委員關注重建方案能否盡用地積比率及高度限制,房協及後就適度放寬漁光村地盤的建築物高度限制進行了可行性研究及技術評估,並向城市規劃委員會提交規劃申請,擬議略為放寬建築物高度限制。

As some Members expressed their concern on whether the plot ratio and height could be fully utilized, HKHS has subsequently carried out feasibility study and technical assessments regarding the minor relaxation of building height restrictions in support of YKC Redevelopment and submitted an application to the Town Planning Board accordingly.

按《城市規劃條例》第 16 條規劃申請的既定程序,在法定提交意見時限內一共收到 3 份意見書,房協已就有關意見及其他部門意見,向城市規劃委員會提交進一步資料處理。

During the statutory period under the Town Planning Ordinance for making comment on the Section 16 application, 3 public comments were received. HKHS has already addressed these comments together with other departmental comments in the Further Information Submission to the Town Planning Board.

房協亦曾於2013年10月為漁光村居民舉辦簡報會,收集居民意見,出席者普遍支持漁光村重建。

HKHS also arranged briefing sessions for local residents of Yue Kwong Chuen in October 2013 to collect their views. Stakeholders are in general supportive to the redevelopment of YKC.
