Report on the enlarged meeting of the Development and Housing Committee held on 2 May 2014

- (1) During the enlarged meeting, the councillors and Committee members discussed the following:
 - (i) Progress Report on 2014/2015 Sha Tin District Major Works Projects submitted by the Civil Engineering and Development Department; and
 - (ii) 2014 Outline Work Plan for Sha Tin District Public Housing Management submitted by the Housing Department, and unanimously passed the following provisional motion:

"Given the seriousness of the problem of throwing objects from height in public rental housing (PRH) estates, Falling Object Monitoring Systems ('eyes in the sky') presently installed on the roofs of PRH estates in Sha Tin are insufficient, and as there are many blind spots, performance of the monitoring systems is affected. Therefore, the Development and Housing Committee of the Sha Tin District Council strongly requests the Housing Department to install mobile Falling Object Monitoring Systems ('eyes in the sky') at various PRH estates in Sha Tin to monitor the problem of throwing objects from height, thereby safeguarding public lives and safety."

- (2) The Committee discussed the following:
 - (i) paper on "Draft Tai Po Kau Development Permission Area Plan No. DPA/NE-TPK/1" submitted by the Planning Department;
 - (ii) paper on "Public Housing Development Project in Fo Tan and Home Ownership Scheme Development Project at Wo Sheung Tun Street" submitted by the Housing Department; and

(iii) replies of the Food and Environmental Hygiene Department, the Hong Kong Police Force, the Housing Department, the Leisure and Cultural Services Department, the Planning Department and the Transport Department to the question on "Planning of Community Facilities in Tai Wai".
