Report on the meeting of the
Finance and General Affairs Committee held on 15 July 2014

(1) The Committee endorsed the following:

- (i) funding application of the Leisure and Cultural Services Department for organising recreation and sports activities from August 2014 to March 2015 in Sha Tin District, details were as follows:

<u>Activity Name</u>	<u>Amount applied for</u>
(a) Recreation and Sports Activities from August 2014 to November 2014	\$2,474,496
(b) Recreation and Sports Activities from December 2014 to March 2015	\$1,616,188

As the amount exceeded \$1,000,000, the application had to be recommended to the Sha Tin District Council (STDC) for consideration via the Committee;

- (ii) funding application submitted by the Sha Tin District Fire Safety Committee, details were as follows:

<u>Activity Name</u>	<u>Amount applied for</u>
(a) Fire Safety Ideas 2014-2015	\$14,000
(b) Sha Tin District Fire Safety Carnival 2014-2015	\$110,000
(c) Fire Safety, a Job for Us All 2014-2015	\$25,000
(d) All about Fire Safety 2014-2015	\$16,000

- (iii) funding application submitted by the Sha Tin District Fight Crime Committee, details were as follows:

<u>Activity Name</u>	<u>Amount applied for</u>
(a) Interactive Anti-crime and Anti-drug Talks for Schools	\$1,000
(b) Sha Tin District “No Drugs” Dance Competition 2014	\$38,000
(iv) funding application in the amount of \$480,000 for “Sha Tin Festival Musical” submitted by the Sha Tin Arts and Culture Promotion Committee;	
(v) funding application in the amount of \$859,500 for “2014/2015 Sha Tin Festive Lighting” submitted by the Planning Committee on Festive Lighting in Sha Tin;	
(vi) funding application in the amount of \$1,140,500 for “2014/2015 Sha Tin Festive Lighting – Installation and Demolition of Lighting” submitted by the Planning Committee on Festive Lighting in Sha Tin. As the amount exceeded \$1,000,000, the application had to be recommended to the STDC for consideration via the Committee; and	
(vii) funding application in the amount of \$1,300,000 for “Sha Tin Mid-Autumn Festival Celebration Night cum Sha Tin Festival 2014 Opening Ceremony” submitted by the Working Group on Mid-Autumn Festival under the Culture, Sports and Community Development Committee As the amount exceeded \$1,000,000, the application had to be recommended to the STDC for consideration via the Committee.
