Report on the enlarged meeting of the
Culture, Sports and Community Development Committee held on 25 April 2013

- (1) During the enlarged meeting, the councillors and Committee members discussed the paper on *Strengthening of Cooperation between Women's Commission and District Councils* submitted by Women's Commission.
- (2) The Committee discussed the following:
 - (i) response of government departments to matters arising from the previous meeting;
 - (ii) *Progress of Capital Works Projects Related to Leisure and Cultural Services Facilities in Sha Tin* submitted by the Leisure and Cultural Services Department (LCSD), and unanimously passed the following provisional motion:

“The Culture, Sports and Community Development Committee of the Sha Tin District Council strongly requests the government to incorporate indoor heated pool facilities in the sports complex project in Area 103, so that residents of Ma On Shan could go swimming all the year round to strengthen their physique”; and
 - (iii) the paper on *Design Option for the Sports Centre in Area 24D, Sha Tin* submitted by the LCSD.
- (3) The Committee endorsed the following:
 - (i) organisation of an activity temporarily named “Corruption-free Hong Kong Stepping into 40” in Sha Tin jointly with the Independent Commission Against Corruption, and election of Mr CHAN Nok-hang, Mr CHENG Cho-kwong, Mr CHIU Man-leong, Mr LEUNG Ka-fai and Mr

PUN Kwok-shan as members of the Organising Committee for Anti-corruption Activities in Sha Tin;

- (ii) funding applications submitted by Sha Tin District National Education Committee for “Tasting Chinese Culture Cooking Competition” and “Online Promotion”, the amounts being applied for were \$241,496.4 and \$20,000 respectively; and
- (iii) funding applications submitted by Sha Tin Celebration Committee for “Sha Tin Joint School Arts Exposition Celebrating Hong Kong's Reunification with China 2013 cum the 9th Sha Tin District Outstanding Student Award Presentation Ceremony” and “Activities Celebrating National Day of China”, the amounts being applied for were \$64,540 and \$135,460 respectively.

(4) The Committee noted the following:

- (i) minutes of meeting of the Committee’s Working Group on Mid-Autumn Festival;
- (ii) papers submitted by the LCSD, including *Report on Organisation of Cultural Activities and Utilisation of Facilities in Sha Tin District*, *Report on Organisation of Recreation and Sports Activities and Management of Facilities in Sha Tin District*, and *Report on Public Libraries Promotion Activities in Sha Tin District*;
- (iii) progress report submitted by the Sha Tin Arts Association;
- (iv) progress report submitted by the Sha Tin Sports Association; and
- (v) 2013/2014 approved estimates of Expenditure Heads under the Committee.
