

## Sha Tin District Council

## Report on the enlarged meeting of the Culture, Sports and Community Development Committee held on 23 February 2012

- (1) During the enlarged meeting, the members endorsed the following:
  - (i) Ms CHAN Man-kuen, Mr CHONG Yiu-kan, Sherman, Ms LAM Chung-yan and Mr LI Sai-wing would represent the Sha Tin District as Directors of the Sha Tin Arts Association:
  - (ii) Mr LEE Kam-ming and Ms TUNG Kin-lei were elected as Sports Ambassadors representing the Sha Tin District, who would assist in the promotion of sports activities in the community; and
  - (iii) Mr LAW Kwong-keung would serve as a member of the 4th Hong Kong Games Organising Committee.
- (2) The members noted and discussed the paper Application by the Kitchee Foundation Limited for the Renting of Sha Tin Area 11 to Run a Football Training Centre submitted by the Leisure and Cultural Services Department (LCSD).
- (3) The members endorsed the following:
  - (i) formation of three standing working groups under the Committee, viz. Working Group on Promotion of Civic-Mindedness and Youth Affairs, Working Group on Community Involvement by Women and Working Group on Sha Tin Recreation and Sports Development, and the Convenors elected for the above working groups were as follows:

- (iii) reservation of \$899,000 and \$52,084 under Expenditure Head 1 (Cultural Affairs) for the LCSD to organise community arts programmes and library promotional activities respectively. The members also endorsed the funding applications from community organisations for 2012/2013 totalling \$1,766,110 under Expenditure Head 1 (Cultural Affairs), as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
- (iv) reservation of \$5,790,300 under Expenditure Head 6 (Recreation and Sports) for the LCSD to organise recreation and sports activities. The members also endorsed the funding applications from community organisations for 2012/2013 totalling \$1,333,800 under Expenditure Head 6 (Recreation and Sports), as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
- (v) the proposed estimates under Expenditure Head 8 (Festival Celebration) with a reserved funding of \$5,500,000 for "Christmas and New Year Lighting", "Dragon Boat Race", "Reunification, National Day and

- Celebration Activities", "Mid-Autumn Festival Activities" and "Large Scale District Activities";
- (vi) reservation of a total of \$897,000 under Expenditure Head 10 (Community Development) for the Working Group on Promotion of Civic-Mindedness and Youth Affairs, the Working Group on Community Involvement by Women, the Working Group on Recreation and Sports Development, as well as for national education activities and anti-corruption activities. The members also endorsed the funding applications from community organisations for 2012/2013 totalling \$720,397 under Expenditure Head 10 (Community Development), as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
- (vii) reservation of a total of \$220,000 under Expenditure Head 11 (Community Organisations) for four Area Committees and the Mutual Aid Committees newly established after the first round of funding allocation. The members also endorsed the funding applications from community organisations for 2012/2013 totalling \$700,457.50 under Expenditure Head 11 (Community Organisations), as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
- (viii) the funding application in the amount of \$5,790,300 submitted by the LCSD for "Recreation and Sports Activities Programme from April 2012 to March 2013 Organised by the LCSD in Sha Tin District". As the amount exceeded \$1,000,000, the application had to be recommended to the Council for consideration via the Finance and General Affairs Committee:
- (ix) the funding application in the amount of \$905,800 submitted by the LCSD for "Proposed District Free Entertainment Programmes from April 2012 to March 2013 Jointly Organised with the LCSD". As the amount exceeded \$250,000, the application had to be recommended to the Finance and General Affairs Committee for consideration;
- (x) the funding application in the amount of \$52,084 submitted by the LCSD for "Public Libraries Promotion Activities from April 2012 to March 2013
  Organised by the LCSD in Sha Tin District"; and

(xi) the funding application in the amount of \$800,000 submitted by the Sha Tin Sports Association for "Sha Tin Dragon Boat Race 2012". As the amount exceeded \$250,000, the application had to be recommended to the Finance and General Affairs Committee for consideration.

(4) The members noted the member list and the report of meeting submitted by the Committee's Working Group on the Screening of Funding Applications (Ad Hoc).
