Report on the meeting of the  
Culture, Sports and Community Development Committee  
held on 26 April 2012

---

- (1) The Committee endorsed the following:
- (i) organisation of an anti-corruption activity in Sha Tin under the theme “integrity” in collaboration with the Independent Commission Against Corruption, and election of Ms LAM Chung-yan, Mr LAW Kwong-keung, Mr LEE Kam-ming and Mr LI Sai-wing as members of the Organising Committee for Anti-corruption Activities in Sha Tin;
  - (ii) formation of the Working Group on Mid-Autumn Festival under the Committee and adoption of its terms of reference, with Mr PANG Cheung-wai, Thomas as the convenor;
  - (iii) revised member list and terms of reference of the Working Group on Sha Tin Recreation and Sports Development under the Committee;
  - (iv) 2012/13 Work Plans of the three working groups under the Committee, viz. Working Group on Promotion of Civic-Mindedness and Youth Affairs, Working Group on Community Involvement by Women and Working Group on Sha Tin Recreation and Sports Development;
  - (v) funding application in the amount of \$306,560 for “Cantonese Opera Show in Celebration of the 15<sup>th</sup> Anniversary of the Establishment of the HKSAR” submitted by the Sha Tin District Organising Committee for the Celebration of the 15th Anniversary of the Establishment of the HKSAR. As the amount exceeded \$250,000, the application had to be recommended to the Finance and General Affairs Committee for consideration;

- (vi) eighteen funding applications in the amount of \$199,513 for local activities and funding application in the amount of \$20,000 for online promotion submitted by the Sha Tin District National Education Committee; and
  - (vii) funding application in the amount of \$60,000 for Lunar New Year Lantern Carnival 2013 submitted by the Shatin Inhabitants Association and the Shatin Communities Activities Committee.
- (2) The Committee noted the following:
- (i) paper on the progress of capital works projects related to leisure and cultural services facilities in Sha Tin submitted by the Leisure and Cultural Services Department (LCSD);
  - (ii) replies of the LCSD and Hong Kong Police Force to the question on the opening hours of Sha Tin Park;
  - (iii) papers submitted by the LCSD, including *Report on Organisation of Cultural Activities and Utilisation of Facilities in Sha Tin*, *Report on Organisation of Recreation and Sports Activities and Management of Facilities in Sha Tin*, and *Report on Promotional Activities of Public Libraries in Sha Tin from January to June 2012*;
  - (iv) progress report submitted by the Sha Tin Arts Association;
  - (v) progress report submitted by the Sha Tin Sports Association; and
  - (vi) 2012/2013 Approved Estimates of Expenditure Heads under the Committee.
