Election of Chairman and Vice-Chairman

- 1. The Chairman of the District Council (DC) welcomed all to the resumption of the first meeting of the current-term District Facilities Management Committee (DFMC). He said that according to Order 34 of the Sha Tin District Council Standing Orders (Standing Orders), a committee of the Council should elect two members of the committee as Chairman and Vice-Chairman of the committee. Since the office of Vice-Chairman of this committee was left vacant for the time being, he would chair the meeting before the Vice-Chairman was elected.
- The Chairman of the DC informed the meeting that the election of Vice-Chairman 2. would be conducted according to the procedures set out in paragraphs 5-7 and 9-14 of Appendix II of the Standing Orders. A member elected as Vice-Chairman of the committee could not hold office as Chairman or Vice-Chairman of another committee at the same time. The election procedures were the same as those of Chairman of the committee on 27 January. Therefore, they would not be elaborated this time. The Secretariat had issued the notice of resumption of meeting for the committee on 28 January, with the nomination forms for the election of Vice-Chairman and the election procedures attached. Nominations for the election of Vice-Chairman of the committee had been cut off at 1:30 pm on the same day, and the first meetings of the committees would be resumed one after another.
- 3. The Chairman of the DC announced that the election of Vice-Chairman of the DFMC began.
