#### **Election of Vice-Chairman**

The Chairman of the District Council (DC) said that the Secretariat had issued the notices of resumption of meetings for the three committees on 27 January, with the nomination forms for the election of Vice-Chairman and the election procedures attached. Nominations for the election of Vice-Chairmen of the three committees had been cut off at 1:30 pm on the same day. The three committees would hold their first meetings (resumption of meetings) one after another. He welcomed Members to the first meeting (resumption of meeting) of the current-term Development & Housing Committee (DHC). He said that according to Order 34 of the Sha Tin District Council Standing Orders (Standing Orders), a committee of the Council should elect two members of the committee as Chairman and Vice-Chairman of the committee. He would chair the meetings before the Chairmen and Vice-Chairmen of the committees were elected,.

- 2. The Chairman of the DC informed the meeting that the election of Vice-Chairman would be conducted according to the procedures set out in paragraphs 5-7 and 9-14 of Appendix II of the Standing Orders. A member elected as Vice-Chairman of the committee could not hold office as Chairman or Vice-Chairman of another committee at the same time. The election procedures were the same as those of Chairman of the committee on 27 January. Therefore, they would not be elaborated this time.
- 3. <u>The Chairman of the DC</u> announced that the election of Vice-Chairman of the DHC began.
