Amendment to Approved Expenditure Items of and Funding Criteria for Projects Funded by the District Council in the "Sha Tin District Council Funding Application Procedures and Guidelines"

Mr CHING Cheung-ying said that "Working Group on Review of Funding Criteria 6. of Sha Tin District Council (Ad Hoc)" (Working Group) already reviewed the approved expenditure items and funding criteria and proposed recommendations on amendments.

He added that the approved expenditure items and funding criteria were adjusted in the review according to actual situation, with reference to the inflation rate over the past two years. He extended his thanks to members of the Working Group.

7. Members unanimously endorsed the above proposed amendments and the recommendation of the same to the Sha Tin District Council (STDC) for deliberation.

Since the above activity must be held during the Spring Festival, if it failed to be held on or before 10 February 2017, it could only be held after 10 February of the fiscal year subject to the special approval by the FGAC according to the provisions of Item 1.3 of Sha Tin District Council Funding Application Procedures and Guidelines.
- 9. Members unanimously endorsed the above funding application, and approved that if necessary, the activity mentioned above could be held after 10 February 2017 according to actual situation.
