- 8. The Chairman said it was pointed out in the 2017 Policy Address that an additional \$100 million would be allocated annually to the Community Involvement Project. The Home Affairs Department (HAD) notified in early May 2017 that the overall allocation to Sha Tin District Council (STDC) for financial year 2017-2018 was \$32,520,000, and the STDC would revise the estimates based on this amount of funding. In accordance with the Sha Tin District Council Budgetary Procedures, the FGAC would be responsible for reviewing the estimates for the Community Involvement Project and submitting the estimates to the STDC for examination and approval.
- 9. The Chairman announced that according to Order 8 of the Sha Tin District Council Standing Orders, a special meeting of the FGAC would be held in the Sha Tin District Council Conference Room at 2:30 pm on 23 May 2017 (Tuesday), to discuss the revised estimates of the STDC, so as to recommend the relevant revised estimates to the STDC for examination and approval at the meeting on 25 May this year, so that the STDC, relevant committees and working groups could start their work according to the revised estimates as soon as possible. He asked the Secretariat to help collate the documents relating to the STDC's revised estimates and send the documents to members before the special meeting of the FGAC.
