

Report on the meeting of the Culture, Sports and Community Development Committee held on 25 February 2016

- (1) The Committee endorsed the following:
 - (i) Mr WONG Fu-sang, Tiger, Ms CHAN Man-kuen, Ms WONG Ping-fan, Iris and Ms LAM Chung-yan would represent the Sha Tin District as Directors of the Sha Tin Arts Association;
 - (ii) Mr SIU Hin-hong and Ms WONG Ping-fan, Iris were elected as Sports Ambassadors representing the Sha Tin District, who would assist in the promotion of sports activities in the community;
 - (iii) proposed estimates totalling \$2,972,788 under Expenditure Head 1 of 2016/2017. The Committee also endorsed the funding applications from local organisations in the amount of \$1,841,895 under Expenditure Head 1 of 2016/2017, as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
 - (iv) proposed estimates totalling \$8,750,000 under Expenditure Head 6 of 2016/2017. The Committee also endorsed the funding applications from local organisations in the amount of \$1,447,248 under Expenditure Head 6 of 2016/2017, as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
 - (v) proposed estimates totalling \$5,862,000 under Expenditure Head 8 of 2016/2017;
 - (vi) proposed estimates totalling \$1,074,400 under Expenditure Head 10 of 2016/2017. The Committee also endorsed the funding applications from local organisations in the amount of \$810,517 under Expenditure Head 10 of 2016/2017, as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
 - (vii) proposed estimates totalling \$964,400 under Expenditure Head 11 of

- 2016/2017. The Committee also endorsed the funding applications from local organisations in the amount of \$964,400 under Expenditure Head 11 of 2016/2017, as recommended by the Working Group on the Screening of Funding Applications (Ad Hoc);
- (viii) funding application in the amount of \$1,059,500 submitted by the Leisure and Cultural Services Department (LCSD) for "Proposed District Free Entertainment Programmes from April 2016 to March 2017 Jointly Organised with the Leisure and Cultural Services Department". As the amount exceeded \$1,000,000, the application had to be recommended to the Sha Tin District Council for consideration via the Finance and General Affairs Committee (FGAC);
- (ix) funding application totalling \$7,300,000 submitted by the LCSD for "Proposed Recreation and Sports Activities from April 2016 to March 2017 Organised by the Leisure and Cultural Services Department in Sha Tin District". As the amount exceeded \$1,000,000, the application had to be recommended to the Sha Tin District Council for consideration via the FGAC:
- (x) funding application in the amount of \$64,613 submitted by the LCSD for "Proposed Public Libraries Promotion Activities from April 2016 to March 2017 Organised by the Leisure and Cultural Services Department in Sha Tin District"; and
- (xi) funding application in the amount of \$800,000 submitted by the Sha Tin Sports Association. As the amount exceeded \$250,000, the application had to be recommended to the FGAC for consideration.
