Report on the meeting of the  
Culture, Sports and Community Development Committee held on 26 October 2017

- (1) The Committee discussed the proposed facilities of “Sports Centre at Ma On Shan Area 103” and passed the following provisional motion:

“The Culture, Sports and Community Development Committee of the Sha Tin District Council requests the Government to include facilities such as a public market, a cooked food centre and a children’s balance bike cycling ground in the ‘Sports Centre at Ma On Shan Area 103’ project to address the community’s needs. Meanwhile, the Committee requests that sufficient public car parking spaces be provided to make up the inadequate supply of existing car parking spaces in the temporary car park at the site. In addition, the Government should review the demand for a new library items central processing centre in Ma On Shan District before submitting the result to the Committee for discussion.”

- (2) The Committee endorsed the following:

- (i) the funding application submitted by the Sha Tin Arts and Culture Promotion Committee, with the following details:

	<u>Name of Activity</u>	<u>Amount Applied for</u>
(a)	Docent Programme on Arts	\$200,000
(b)	Film Appreciation Programme	\$170,000
(c)	Theatre Workshop	\$120,000

- (ii) the funding application in the amount of \$760,000 for “Celebration of the 20th Anniversary of the Establishment of the HKSAR – Sha Tin Drum Festival – Mega Drum Showcase” submitted by the Sha Tin Arts and Culture Promotion Committee was recommended to the Finance and General Affairs Committee (FGAC) for consideration. In addition, the event was specially approved to be extended to 11 February 2018; and

- (iii) the funding application in the amount of \$110,515.50 for “Love of Nature – AR Floor Painting” submitted by the Sha Tin District National Education Committee, and the application to the FGAC for virement of an additional budget funding of \$136,694.50 from the reserve to Category 10.2 as the balance of funding for activities.
