

Sha Tin District Council

Report on the meeting of the Culture, Sports and Community Development Committee held on 1 March 2018

(1) The Committee discussed the following:

- (i) responses of the Leisure and Cultural Services Department (LCSD), the Architectural Services Department, the Sha Tin District Office (STDO) and the Food and Environmental Hygiene Department to matters arising from the previous meeting; and
- (ii) replies of the Hong Kong Police Force, the STDO, the LCSD and the Environmental Protection Department to the question on "Noise Nuisance at the Riverside of Shing Mun River". The provisional motion below was passed:

"The Culture, Sports and Community Development Committee of the Sha Tin District Council strongly requests the District Officer (Sha Tin) to coordinate different departments, set up working groups and adopt effective measures to solve the problem of noise nuisance caused by dancing and singing at the riverside of Shing Mun River." (Unanimously passed)

(2) The Committee endorsed the following:

- (i) proposed estimates totalling \$4,308,299 under Expenditure Head 1 of 2018/2019, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications from local organisations in the amount of \$2,890,285 under Expenditure Head 1 of 2018/2019;
- (ii) proposed estimates totalling \$11,055,427 under Expenditure Head 6 of 2018/2019, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications from local organisations in the amount of \$2,228,832 under Expenditure Head 6 of 2018/2019;

- (iii) proposed estimates totalling \$9,393,603 under Expenditure Head 8 of 2018/2019;
- (iv) proposed estimates totalling \$1,411,746 under Expenditure Head 10 of 2018/2019, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications from local organisations in the amount of \$977,592 under Expenditure Head 10 of 2018/2019;
- (v) proposed estimates totalling \$1,331,848 under Expenditure Head 11 of 2018/2019, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications from local organisations in the amount of \$787,727 under Expenditure Head 11 of 2018/2019;
- (vi) funding application in the amount of \$1,322,014 submitted by the LCSD for "Proposed District Free Entertainment Programmes from April 2018 to March 2019 Jointly Organised with the Leisure and Cultural Services Department". As the amount exceeded \$1 million, the application had to be recommended to the Sha Tin District Council for consideration via the Finance and General Affairs Committee (FGAC);
- (vii) funding application in the amount of \$8,694,635 submitted by the LCSD for "Recreation and Sports Activities Programme from April 2018 to March 2019 Organised by the Leisure and Cultural Services Department in Sha Tin District". As the amount exceeded \$1 million, the application had to be recommended to the Sha Tin District Council for consideration via the FGAC;
- (viii) funding application in the amount of \$96,390 submitted by the LCSD for "Promotional Activities of Public Libraries from April 2018 to March 2019 Organised by the Leisure and Cultural Services Department in Sha Tin District";
- (ix) funding application in the amount of \$800,000 submitted by the Sha Tin Sports Association. As the amount exceeded \$250,000, the application had to be recommended to the FGAC for consideration;
- (x) funding application submitted by the Sha Tin Arts and Culture Promotion Committee, with the following details:
