Sha Tin District Council

Report on the meeting of the
Culture, Sports and Community Development Committee held on 6 September 2018

- (1) The Committee discussed the following:
- (i) the replies of the Sha Tin District Office (STDO), the Leisure and Cultural Services Department (LCSD) and the Hong Kong Police Force (HKPF) to matters arising from the previous meeting;
 - (ii) the replies of the STDO, the LCSD, the Planning Department, the District Lands Office/Sharing Tin, the Highways Department, the Transport Department, the Environmental Protection Department (EPD), and the Food and Environmental Hygiene Department (FEHD) to the question on “Following Up on the Work Progress of the Working Group on Noise Nuisance Caused by Singing and Dancing on the Banks of Shing Mun River”, and endorsed the relevant provisional motion:

“The Culture, Sports and Community Development Committee of the Sha Tin District Council urges the Government to seriously follow up the noise problem caused by singing and dancing on the banks of Shing Mun River by:

(1) setting up a working group led by the District Officer as soon as possible to settle the problem;

(2) stepping up law enforcement by the HKPF.”
