Report on the meeting of the
Culture, Sports and Community Development Committee held on 1 November 2018

- (1) The Committee discussed the following:
- (i) the replies of the Sha Tin District Office (STDO) and the Hong Kong Police Force (HKPF) to matters arising from the previous meeting; and
