Report on the meeting of the Culture, Sports and Community Development Committee held on 28 February 2019

(1) The Committee discussed the following:

- (i) responses of the Transport Department to matters arising from the previous meeting; and
- (ii) the discussion papers submitted by the Food and Environmental Hygiene Department in respect of the application of the "M.O.S. Bazaar Project".

(2) The Committee endorsed the following:

- (i) the proposed estimates totalling \$4,308,285 under Expenditure Head 1 of 2019/2020, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications for \$2,818,110 by local organisations under Expenditure Head 1 of 2019/2020;
- (ii) the proposed estimates totalling \$11,655,427 under Expenditure Head 6 of 2019/2020, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications for \$2,360,710 by local organisations under Expenditure Head 6 of 2019/2020;
- (iii) the proposed estimates totalling \$8,870,000 under Expenditure Head 8 of 2019/2020;
- (iv) the proposed estimates totalling \$1,407,746 under Expenditure Head 10 of 2019/2020, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications for \$1,012,558 by local organisations under Expenditure Head 10 of 2019/2020 (The Working Group on Screening of Funding Application (Ad Hoc) endorsed the funding proposals of "Day Trip to Hong Kong Wetland Park" and "Day Trip to Tuen Mun" submitted by the Kam Ying

Court Residents' Association with 11 affirmative votes, 4 dissenting votes, 5 abstention votes and 2 members opted not to vote, and 9 affirmative votes, 7 dissenting votes, 3 abstention votes and 2 attending members opted not to vote respectively);

- the proposed estimates totalling \$1,331,848 under Expenditure Head 11 of 2019/2020, and, as recommended by the Working Group on Screening of Funding Application (Ad Hoc), the funding applications for \$883,865 by local organisations under Expenditure Head 11 of 2019/2020 (The Working Group on Screening of Funding Application (Ad Hoc) endorsed the funding proposals of "Day Trip to Kam Tin" and "Day Trip to Tap Mun" submitted by the Owners' Corporation of Kam Ying Court Phase II with 10 affirmative votes, 7 dissenting votes, 2 abstention votes and 3 members opted not to vote, and 9 affirmative votes, 8 dissenting votes, 2 abstention votes and 3 members opted not to vote respectively. The working group did not endorse the funding proposal of "Day Trip to Kadoorie Farm and Botanic Garden" submitted by the Owners' Corporation of Kam Ying Court Phase II with 9 affirmative votes, 10 dissenting votes, 2 abstention votes and 1 member opted not to vote);
- (vi) the funding application for \$1,322,000 submitted by the Leisure and Cultural Services Department (LCSD) for "Proposed District Free Entertainment Programmes from April 2019 to March 2020 Jointly Organised with the Leisure and Cultural Services Department". As the amount exceeded \$1 million, the application had to be recommended to the Sha Tin District Council (STDC) for consideration via the Finance and General Affairs Committee (FGAC);
- (vii) the funding application for \$9,294,635 submitted by the LCSD for "Recreation and Sports Activities Programme from April 2019 to March 2020 Organised by the Leisure and Cultural Services Department in Sha Tin District". As the amount exceeded \$1 million, the application had to be recommended to the STDC for consideration via the FGAC;
- (viii) the funding application for \$95,840 submitted by the LCSD for "Promotional Activities of Public Libraries from April 2019 to March 2020 Organised by the Leisure and Cultural Services Department in Sha Tin District"; and

(ix) the funding application of \$800,000 submitted by the Sha Tin Sports Association. As the amount exceeded \$250,000, the application had to be recommended to the FGAC for consideration;
