Report on the meeting of the Culture, Sports and Community Development Committee held on 2 May 2019

- (1) The Committee discussed the following:
 - (i) the responses of the Food and Environmental Hygiene Department (FEHD), the Housing Department, the Leisure and Cultural Services Department (LCSD) and the Architectural Services Department to matters arising from the previous meeting;
 - (ii) the paper on "2019-20 Leisure and Cultural Services Department Annual Work Plan Progress of Capital Works Projects Related to Leisure and Cultural Services Facilities in Sha Tin" submitted by the LCSD, with the relevant provisional motion passed:
 - "With the upcoming intake of Chun Yeung Estate and successive completion of many other housing estates in future, the population of Fo Tan Area is expected to significantly increase. This will exert great pressure on the transportation and community facilities.

It is necessary for the Government to ensure that the traffic and transport in the area will not be affected by the development, and sufficient community facilities including car park, sports centre, library, etc., will be provided to cope with the population growth.

As such, the Committee requests that the Government immediately commence the design of the culture, sports and community complex at Shan Mei Street, including the sports centre, library, community hall and a car park with sufficient parking spaces; it will better serve the needs of the Fo Tan community if Fo Tan Cooked Food Market (West) is resumed for development; the Committee also requests relevant government departments to submit relevant progress reports to the District Council of the current term."; and

- (iii) the responses of the Hong Kong Police Force, the Hong Kong Immigration Department, the Home Affairs Bureau, the Sha Tin District Office, the District Lands Office, Sha Tin, the Environmental Protection Department and the FEHD to the question on "Street Performance in Public Places".
