Report on the Meeting of the Culture, Sports and Community Development Committee held on 28 October 2021

(1) The nomination and result of the election of Vice-Chairman of the Committee was as follows:

the Secretariat did not receive any nomination form by the end of the nomination period, the post of Vice-Chairman of the Committee was therefore vacant.

- (2) The Committee discussed the following:
 - (i) the Proposed Facilities of Whitehead Sports Park; and
 - (ii) the Construction of a Joint-User Complex for Community Facilities at Shan Mei Street in Fo Tan, and passed the following provisional motion:

"Background:

The Development Bureau and the Government Property Agency announce at the meeting of the Culture, Sports and Community Development Committee (CSCDC) of the Sha Tin District Council (STDC) the latest plan for the Joint-User Complex in Fo Tan, where no space will be reserved for the reprovisioning of the cooked food markets, and the Government has no intention to reprovision the cooked food centres on the land nearby. The cooked food markets in Fo Tan will be forced to cease business, which will be a loss of district characteristic in Sha Tin. Thus, the CSCDC of the STDC hereby moves that:

- (1) it demands that the Government reserve space for the reprovisioning of the cooked food markets in the government Joint-User Complex under planning or on the land with no development uses near Fo Tan Cooked Food Market (West)
- (2) it demands that the Government provide the timetables for the resumption of Fo Tan Cooked Food Markets (East and West) and the construction of the Joint-User Complex
- (3) it demands that the Government provide temporary transitional arrangements for stall operators to continue business prior to a permanent reprovisioning of the cooked food markets."
- (3) The Committee endorsed Mr HUI Lap-san and Mr WAI Hing-cheung to be Members of the Kitchee Shatin Consultative Committee.

- (4) The Committee noted the following:
 - (i) the papers submitted by the Leisure and Cultural Services Department, including "Report and Plan by the Leisure and Cultural Services Department on Organisation of Cultural Activities and Utilisation of Facilities in Sha Tin District (3rd and 4th Quarters of 2021)", "Report and Plan by the Leisure and Cultural Services Department on Organisation of Recreation and Sports Activities and Management of Facilities in Sha Tin District (3rd and 4th Quarters of 2021)" and "Report and Plan on Public Libraries Promotion Activities Organised by the Leisure and Cultural Services Department in Sha Tin District (3rd to 4th Quarters of 2021)";
 - (ii) the Progress Report of the Sha Tin Arts Association; and
 - (iii) the Progress Report of the Sha Tin Sports Association.
