I. GENERAL SITUATION

1. Overall Crime

- (1) There were 590 reported crimes in DEC 2013 JAN 2014, a decrease of 17.3% compared with 713 in DEC 2012 JAN 2013. The decrease in reported crimes was mainly in cases of :
 - Triad Related Crimes (-38 / -74.5%);
 - Miscellaneous Thefts (-37 / -21.6%);
 - Violent Crime (-28 / -25%);
 - Wounding and Serious Assault (-27 / -40.3%); and
 - Shop Theft (-23 / -19.7%)

The offences that increased included :

- Technology Crimes (+19 / +118.8%);
- Deception (+16 / +35.6%);
- Debt Collection Related Crimes (+5 / +35.7%); and
- Missing Motor Vehicles (+4 / +200%)
- (2) The detection rate in DEC 2013 JAN 2014 was 39.8%, compared with 46.6% in DEC 2012 - JAN 2013.

- (3) There were 3,735 reported crimes in Jan Dec 2013, a decrease of 14.9% compared with 4,390 in Jan Dec 2012. The overall crime situation remains stable.
- (4) The detection rate in Jan Dec 2013 was 47.3%, compared with 46.2% in Jan Dec 2012.
- (5) When comparing Jan Dec 2013 with Jan Dec 2012, the decrease in reported crimes was mainly due to the decrease in cases of :
 - Miscellaneous Thefts (-247 / -22.8%);
 - Violent Crime (-132 / -15.1%);
 - Triad Related Crimes (-65 / -35.3%);
 - Debt Collection Related Crimes (-51 / -36.2%);
 - Burglary (-26 / -16.5%); and
 - Wounding and Serious Assault (-23 / -5.3%).

The offences with an increase include :

- Technology Crimes (+56 / +40.6%);
- Missing Motor Vehicles (+21 / +100%);
- Serious Narcotics Offences (+17 / +12.2%); and
- Snatching (+11 / +100%).

- (6) There were 299 reported crimes in Jan 2014, a decrease of 8.8% compared with 328 in Jan 2013.
- (7) The detection rate in Jan 2014 was 40.5%, compared with 39.6% in Jan 2013.
- (8) When comparing Jan with the same period in 2013, the decrease in reported crimes was mainly due to the decrease of :
 - Miscellaneous Thefts (-16 / -20.3%);
 - Shop Theft (-14 / -24.1%);
 - Violent Crime (-8 / -15.1%); and
 - Wounding and Serious Assault (-7 / -21.2%).

The offences with an increase include :

• Technology Crimes (+9 / +100%);

- Deception (+6 / +20.7%); and
- Debt Collection Related Crimes (+5 / +125%).

- (3) There were 743 Violent Crimes in Jan Dec 2013, a decrease of 15.1% compared with 875 in Jan Dec 2012.
- (4) The detection rate in Jan Dec 2013 was 65.7%, compared with 69.4% in Jan Dec 2012.
- (5) There were 45 Violent Crimes in Jan 2014, a decrease of 15.1% compared with 53 in Jan 2013.

- There were 26 cases of Serious Narcotics Offences in DEC 2013 JAN 2014, a decrease of 13.3% compared with 30 in DEC 2012 - JAN 2013.
- (2) There were 22 cases of Serious Narcotics Offences involving Psychotropic substances, a decrease of 21.4% compared with 28 cases in DEC 2012 JAN 2013. There were 4 cases of Serious Narcotics Offences involving Heroin in DEC 2013 JAN 2014, an increase of 100% compared with 2 cases in DEC 2012 JAN 2013.
- (3) In DEC 2013 JAN 2014, cases involving Heroin and Psychotropic substances accounted for 15.4% and 84.6% respectively of all Serious Narcotics Offences,

- (6) No Juvenile (aged between 10 and 15) was arrested for Serious Narcotics Offences in DEC 2013 JAN 2014, same as in DEC 2012 JAN 2013. 3 Young Persons (aged between 16 and 20) were arrested for Serious Narcotics Offences in DEC 2013 JAN 2014, a decrease of 57.1% compared with 7 in DEC 2012 JAN 2013.

- (10) There were 11 cases of Serious Narcotics Offences in Jan 2014, a decrease of 15.4% compared with 13 in Jan 2013.
- (11) 14 offenders were arrested for Serious Narcotics Offences in Jan 2014, a decrease of 6.7% compared with 15 in Jan 2013.

There were 94 Shop Thefts in DEC 2013 – JAN 2014, a decrease of 19.7% compared with 117 cases in DEC 2012 – JAN 2013.

There were 568 Shop Thefts in Jan – Dec 2013, an increase of 0.5% compared with 565 cases in Jan – Dec 2012.

There were 44 Shop Thefts in Jan 2014, a decrease of 24.1% compared with 58 cases in Jan 2013.

d) <u>Theft From Vehicle</u>

There were 7 cases of Theft From Vehicle in DEC 2013 – JAN 2014, an increase of 16.7% compared with 6 cases in DEC 2012 – JAN 2013.

There were 53 cases of Theft From Vehicle in Jan – Dec 2013, a decrease of 27.4% compared with 73 in Jan – Dec 2012.

There were 2 cases of Theft From Vehicle in Jan 2014, an increase of 100% compared with one in Jan 2013.

e) <u>Miscellaneous Thefts</u>

There were 134 Miscellaneous Thefts in DEC 2013 – JAN 2014, a decrease of 21.6% compared with 171 cases in DEC 2012 – JAN 2013.

There were 835 Miscellaneous Thefts in Jan – Dec 2013, a decrease of 22.8% compared with 1,082 cases in Jan – Dec 2012.

There were 63 Miscellaneous Thefts in Jan 2014, a decrease of 20.3% compared with 79 cases in Jan 2013.

6. <u>Deception</u>

- There were 61 Deception cases in DEC 2013 JAN 2014, an increase of 35.6% compared with 45 in DEC 2012 JAN 2013.
- (2) There were 326 Deception cases in Jan Dec 2013, a decrease of 3.8% compared with 339 in Jan Dec 2012.
- (3) There were 35 Deception cases in Jan 2014, an increase of 20.7% compared with 29 in Jan 2013.

- (4) There were 28 Telephone Deception cases in DEC 2013 JAN 2014, the usual method used by culprits were 'pretending as victim's relative or friend' and 'claiming to be detained due to involvement of vice activities or indebtedness'. There were 7 cases in which the culprits successfully deceived the victims and the total amount lost was HK\$329,267.
- (5) There were 108 Telephone Deception cases in Jan Dec 2013, representing a decrease of 31 cases (-22.3%) when compared with 139 in Jan Dec 2012.
- (6) There were 15 Telephone Deception cases in Jan 2014, representing an increase of 4 cases (+36.4%) when compared with 11 in Jan 2013.

- 17 Domestic Violence cases were handled by the Police in DEC 2013 JAN 2014, a decrease of 29.2% compared with 24 in DEC 2012 JAN 2013. Of the 17 cases in DEC 2013 JAN 2014, 13 were crime cases, a decrease of 23.5% compared with 17 crime cases in DEC 2012 JAN 2013.
- (2) 155 Domestic Violence cases were handled by the Police in Jan Dec 2013, a decrease of 22.9% compared with 201 in Jan Dec 2012. Of the 155 cases in Jan Dec 2013, 114 were crime cases, a decrease of 14.3% compared with 133 crime cases in Jan Dec 2012.

³ For the purpose of police intervention, domestic violence is defined as any incident involving an assault, or a breach of the peace between parties who can generally be described as married or having a family relationship. This includes couples who are married, separated or divorced, and co-habitants or lovers having a lasting relationship. Miscellaneous cases refer to incidents of dispute, requests for Police assistance / investigation, etc. that involve a breach of the peace.

⁴ Domestic Incident refers to all cases of trouble, which have not developed into actual violence (e.g. requests for police assistance, drunkenness, etc.). This classification was introduced in January 2009 to facilitate identification of problem couples or partners for early intervention. Like other Domestic Violence categories, Domestic Incidents are included in the "Enhanced Central Domestic Violence Database" which has a system to alert investigating officer of cases of potential risk for early referral to Social Welfare Department for assistance. The existing definitions and handling procedures of Domestic Violence crime and miscellaneous cases remain unchanged.

- (5) 1,114 Domestic Incident cases were handled by the Police in Jan Dec 2013, an increase of 4% compared with 1,071 in Jan Dec 2012.
- (6) 94 Domestic Incident cases were handled by the Police in Jan 2014, a decrease of 7.8% compared with 102 in Jan 2013.

- (1) There were 12 Indecent Assault cases in DEC 2013 JAN 2014, representing a decrease of 14.3% compared with 14 in DEC 2012 JAN 2013. The majority of cases which were committed by strangers took place in the streets and inside LRT / West Rail compartments.
- (2) There were 105 Indecent Assault cases in Jan Dec 2013, a decrease of 7.1% compared with 113 in Jan Dec 2012.
- (3) There were 8 Indecent Assault cases in Jan 2014, a decrease of 11.1% compared with 9 in Jan 2013.

- There were 35 Technology Crimes in DEC 2013 JAN 2014, an increase of 118.8% compared with 16 in DEC 2012 JAN 2013. The increases in Technology Crimes were largely due to "Naked Chat" cases (+200%); "On-line Game" cases (+150%); and "On-line business fraud" cases (+85.7%).
- (2) There were 194 Technology Crimes in Jan Dec 2013, an increase of 40.6% compared with 138 in Jan Dec 2012.
- (3) There were 18 Technology Crimes in Jan 2014, an increase of 100% compared with 9 in Jan 2013.
