# Tuen Mun District State of Crime Report for Tuen Mun District Council Meeting Covering Period from February to March 2015 <u>Submission by Tuen Mun Police District</u>

# I. GENERAL SITUATION

# 1. Overall Crime

- There were 599 reported crimes in FEB MAR 2015, an increase of 15.2% compared with 520 in FEB MAR 2014. The increase was mainly due to the increase in report of :
  - Shoptheft (+30 / +35.7%);
  - Violent Crimes (+15 / +18.1%);
  - Technology Crimes (+13 / +37.1%);
  - Miscellaneous Thefts (+12 / +9.3%);
  - Theft from Vehicle (+11 / +366.7%); and
  - Wounding and Serious Assault (+9 / +22%).

Whilst the decrease in cases reported were :

- Pickpocketing (-12 / -80%);
- Burglary (-11 / -42.3%);
- Serious Narcotics Offences (-9 / -40.9%);
- Robbery (-4 / -100%);
- Snatching (-3 / -75 %); and
- Domestic Violence Crimes (-3 / -20%).
- (2) The detection rate in FEB MAR 2015 was 41.7%, compared with 44.6% in FEB -MAR 2014.

- (3) There were 891 reported crimes in Jan Mar 2015, an increase of 8.7% compared with 820 in Jan Mar 2014. The overall crime situation remains stable.
- (4) The detection rate in Jan Mar 2015 was 44.3%, compared with 44.9% in Jan Mar 2014.
- (5) When comparing Jan Mar 2015 with Jan Mar 2014, the increase in reported crimes was mainly due to the increase in :
  - Shoptheft (+57 / +44.5%);
  - Technology Crimes (+24 / +45.3%);
  - Theft from Vehicle (+10 / +200%);
  - Violent Crimes (+10 / +7.8%); and
  - Missing Motor Vehicles (+9 / +300%).

Whilst the decrease in cases were :

- Burglary (-24 / -51.1%);
- Pickpocketing (-18 / -75%);
- Serious Narcotics Offences (-11 / 33.3%);
- Domestic Violence Crimes (-10 / -41.7%); and
- Debt-collection Related Crimes (-8 / -38.1%).

- (2) The detection rate in FEB MAR 2015 was 54.1%, a decrease of 1.3% compared with 55.4% in FEB MAR 2014.
- (3) There were 138 Violent Crimes in Jan Mar 2015, an increase of 7.8% compared with 128 in Jan Mar 2014.
- (4) The detection rate in Jan Mar 2015 was 57.2%, compared with 61.7% in Jan Mar 2014.

- There were 13 cases of Serious Narcotics Offences in FEB MAR 2015, a decrease of 40.9% compared with 22 in FEB - MAR 2014.
- (2) There were 13 cases of Serious Narcotics Offences involving Psychotropic substances, a decrease of 40.9% compared with 22 cases in FEB MAR 2014.
- (3) In FEB MAR 2015, cases involving Heroin and Psychotropic substances accounted for 0.0% and 100% respectively of all Serious Narcotics Offences, compared to 0.0% and 100% respectively in FEB - MAR 2014.
- (4) Ketamine is still the most popular drug of seizure.
- (5) 16 offenders were arrested for Serious Narcotics Offences in FEB MAR 2015, a decrease of 40.7% compared with 27 in FEB - MAR 2014.
- (6) One Juvenile (aged between 10 and 15) was arrested for Serious Narcotics Offences in FEB - MAR 2015, but none in FEB - MAR 2014. 2 Young Persons (aged between 16 and 20) were arrested for Serious Narcotics Offences in FEB -MAR 2015, same as in FEB - MAR 2014.
- (7) There were 22 cases of Serious Narcotics Offences in Jan Mar 2015, a decrease of 33.3% compared with 33 in Jan - Mar 2014.
- (8) 27 offenders were arrested for Serious Narcotics Offences in Jan Mar 2015, a decrease of 41.3% compared with 46 in Jan - Mar 2014.
- (9) 3 Juveniles (aged between 10 and 15) were arrested for Serious Narcotics Offences in Jan Mar 2015, an increase of 200% compared with one in Jan Mar 2014.
  7 Young Persons (aged between 16 and 20) were arrested for Serious Narcotics Offences in Jan Mar 2015, a decrease of 41.7% compared with 12 in Jan Mar 2014.

# a) <u>Snatching</u>

There was one Snatching case in FEB - MAR 2015, a decrease of 75% compared with 4 in FEB - MAR 2014.

There were 3 Snatching cases in Jan - Mar 2015, a decrease of 40% compared with 5 in Jan - Mar 2014.

# b) <u>Pickpocketing</u>

There were 3 Pickpocketing cases in FEB - MAR 2015, a decrease of 80% compared with 15 in FEB - MAR 2014. Black spots continue to be San Hui Market area and other crowded Shopping Malls.

There were 6 Pickpocketing cases in Jan – Mar 2015, a decrease of 75% compared with 24 in Jan - Mar 2014.

#### c) <u>Shop Theft</u>

There were 114 Shop Thefts in FEB - MAR 2015, an increase of 35.7% compared with 84 cases in FEB - MAR 2014.

There were 185 Shop Thefts in Jan – Mar 2015, an increase of 44.5% compared with 128 cases in Jan - Mar 2014.

#### d) <u>Theft From Vehicle</u>

There were 14 cases of Theft From Vehicle in FEB - MAR 2015, an increase of 366.7% compared with 3 cases in FEB - MAR 2014.

There were 15 cases of Theft From Vehicle in Jan - Mar 2015, an increase of 200% compared with 5 in Jan - Mar 2014.

#### e) <u>Miscellaneous Thefts</u>

There were 141 Miscellaneous Thefts in FEB - MAR 2015, an increase of 9.3% compared with 129 cases in FEB - MAR 2014.

There were 196 Miscellaneous Thefts in Jan - Mar 2015, an increase of 2.1% compared with 192 cases in Jan - Mar 2014.

#### f) Missing Motor Vehicles

7 motor vehicles were reported missing in FEB - MAR 2015, an increase of 250% compared with 2 in FEB – MAR 2014.

- (1) There were 54 Deception cases in FEB MAR 2015, same as in FEB MAR 2014.
- (2) There were 89 Deception cases in Jan Mar 2015, a decrease of 1.1% compared with 90 in Jan Mar 2014.
- (3) There were 12 Telephone Deception cases in FEB MAR 2015, the usual method used by culprits were 'pretending as victim's relative or friend' and 'claiming to be detained due to involvement of vice activities or indebtedness'. There was no case in which the culprits successfully deceived the victims.
- (4) There were 21 Telephone Deception cases in Jan Mar 2015, representing an increase of 15 cases (-41.7%) when compared with 36 in Jan Mar 2014.

Triad-related crimes normally surface in the form of: Unlawful Society Offences, Wounding and Serious Assault, Blackmail, Criminal Intimidation, Arson and Criminal Damage etc.

- 18 Domestic Violence cases were handled by the Police in FEB MAR 2015, a decrease of 14.3% compared with 21 in FEB MAR 2014. Of the 18 cases in FEB MAR 2015, 12 were crime cases, a decrease of 20% compared with 15 crime cases in FEB MAR 2014.
- (2) 21 Domestic Violence cases were handled by the Police in Jan Mar 2015, a decrease of 32.3% compared with 31 in Jan Mar 2014. Of the 21 cases in Jan Mar 2015, 14 were crime cases, a decrease of 41.7% compared with 24 crime cases in Jan Mar 2014.
- (3) 144 Domestic Incident cases were handled by the Police in FEB MAR 2015, an increase of 9.9% compared with 131 in FEB MAR 2014.
- (4) 229 Domestic Incident cases were handled by the Police in Jan Mar 2015, an increase of 1.8% compared with 225 in Jan Mar 2014.

<sup>&</sup>lt;sup>3</sup> For the purpose of police intervention, domestic violence is defined as any incident involving an assault, or a breach of the peace between parties who can generally be described as married or having a family relationship. This includes couples who are married, separated or divorced, and co-habitants or lovers having a lasting relationship. Miscellaneous cases refer to incidents of dispute, requests for Police assistance / investigation, etc. that involve a breach of the peace.

<sup>&</sup>lt;sup>4</sup> Domestic Incident refers to all cases of trouble, which have not developed into actual violence (e.g. requests for police assistance, drunkenness, etc.). This classification was introduced in January 2009 to facilitate identification of problem couples or partners for early intervention. Like other Domestic Violence categories, Domestic Incidents are included in the "Enhanced Central Domestic Violence Database" which has a system to alert investigating officer of cases of potential risk for early referral to Social Welfare Department for assistance. The existing definitions and handling procedures of Domestic Violence crime and miscellaneous cases remain unchanged.

- 290 offenders were arrested for crimes in FEB MAR 2015, an increase of 6.2% compared with 273 in FEB MAR 2014.
- (2) 12 Juveniles (aged between 10 and 15) were arrested for crimes in FEB MAR 2015, a decrease of 33.3% compared with 18 in FEB MAR 2014. 38 Young Persons (aged between 16 and 20) were arrested for crimes in FEB MAR 2015, same as in FEB MAR 2014.

(3) Crimes Committed by Juvenile and Youth in Tuen Mun Police District in FEB -MAR 2015.



- (4) 449 offenders were arrested for crimes in Jan Mar 2015, a decrease of 2.2% compared with 459 in Jan Mar 2014.
- (5) 29 Juveniles (aged between 10 and 15) were arrested for crimes in Jan Mar 2015, a decrease of 21.6% compared with 37 in Jan Mar 2014. 57 Young Persons (aged between 16 and 20) were arrested for crimes in Jan Mar 2015, a decrease of 14.9% compared with 67 in Jan Mar 2014.

- (1) There were 48 Technology Crimes in FEB MAR 2015, an increase of 37.1% compared with 35 in FEB MAR 2014. The increases in Technology Crimes were mainly due to "Naked Chat" cases (+62.5%); "On-line gamed related" cases (+400%).
- (2) There were 77 Technology Crimes in Jan Mar 2015, an increase of 45.3% compared with 53 in Jan Mar 2014.

<sup>5</sup> For ease of reference and in order to maintain accurate Force Statistics on cyber crime trends, technology crime offences are grouped into four main categories : (a) online game related offences; (b) unauthorized access to computer (e.g. computer hacking, Internet/email account abuse); (c) online business fraud (e.g. e-auction fraud, online shopping fraud, credit card misuse, etc); and (d) others (e.g. child pornography, sexual offences and criminal intimidation, etc).
