#### **Opening Remarks**

Mr LEUNG Kin-man, the Chairman of the TMDC, welcomed Members of the Environment, Hygiene and District Development Committee ("EHDDC") to the first meeting of the EHDDC.

2. Mr LEUNG Kin-man said that according to the TMDC Standing Orders, a committee should elect its chairman and vice-chairman at the first meeting of the committee in each term, and the TMDC Chairman or Vice-chairman should preside over the meeting for the election of the committee's chairman and vice-chairman. Therefore, he stated that he would be presiding over this meeting until the Chairman and Vice-chairman of the EHDDC were elected.

#### I. Election of EHDDC Chairman

- 3. Mr LEUNG Kin-man said that Section 71(3) of the District Councils Ordinance provided that a committee of a District Council ("DC") was to elect a member of the committee who was also a member of the DC as the chairman of the committee. On 6 January 2016, the Secretariat had sent the membership lists of the committees and the nomination forms for the committees' chairmen and vice-chairmen to all Members. The nomination period had closed at 5:00 p.m. on 12 January and the Secretariat had sent the list of the validly-nominated candidates to all Members on the same day.
- 4. Mr LEUNG Kin-man said that the Secretariat had received one nomination for EHDDC Chairman by the end of the nomination period. The Member nominated for EHDDC Chairman was Ms LUNG Shui-hing, who was nominated by Mr Lothar LEE, and the two Members subscribing the nomination were Ms CHING Chi-hung and Mr Leo CHAN.
- 5. As there was only one Member nominated as a candidate for EHDDC Chairman, Mr LEUNG Kin-man announced pursuant to the TMDC Standing Orders that candidate Ms LUNG Shui-hing was elected unopposed as the EHDDC Chairman for the term starting from the date of this meeting until 31 December 2017.

### II. <u>Election of EHDDC Vice-chairman</u>

6. Mr LEUNG Kin-man stated that pursuant to Order 33(3) of the TMDC Standing Orders, a committee might elect a member who was also a TMDC Member as the vice-chairman of the committee.

7. Mr LEUNG Kin-man said that the Secretariat had received one nomination for

EHDDC Vice-chairman by the end of the nomination period. The Member

nominated for EHDDC Vice-chairman was Mr KAM Man-fung, who was nominated

by Mr SO Shiu-shing, and the two Members subscribing the nomination were Ms

CHING Chi-hung and Ms SO Ka-man.

8. As there was only one Member nominated as a candidate for Vice-chairman,

Mr LEUNG Kin-man announced pursuant to the TMDC Standing Orders that

candidate Mr KAM Man-fung was elected unopposed as the EHDDC Vice-chairman

for the term starting from the date of this meeting until 31 December 2017.

9. As the Chairman and Vice-chairman of the EHDDC had been elected, Mr

LEUNG Kin-man turned the meeting over to the EHDDC Chairman.

[The EHDDC Chairman started to preside over the meeting at this point.]

III. Any Other Business

10. The Chairman thanked Members for their support and trust. He hoped

Members would continue to support his future work for the benefit of Tuen Mun

residents.

IV. Date of the Next Meeting

11. There being no further business, the Chairman closed the meeting at 9:50 a.m.

12. The Chairman said that the next meeting was tentatively scheduled for 9:30

a.m., 18 March 2016 (Friday). Subject to the TMDC's official endorsement of the

schedule of meetings, the Secretariat would write to Members informing them of the

confirmed dates of meetings. Members who wished to submit papers might provide

the papers for the Secretariat at least 10 clear working days before the next meeting, i.e.

on or before 3 March tentatively.
