#### I. Opening Remarks

The Vice-chairman welcomed all present to the 12<sup>th</sup> meeting of the Social Services Committee ("SSC"). Since Ms SO Ka-man, the Chairman of the SSC, could not attend the meeting due to illness, he would preside at that meeting.

- 2. The Vice-chairman reminded that Members who were aware of their personal interests in any matters discussed at the meeting should declare the interests before the discussion. He would, in accordance with Order 39(12) of the Tuen Mun District Council Standing Orders ("Standing Orders"), decide whether the Members who had declared interests might speak or vote on the matters, might remain at the meeting as observers, or should withdraw from the meeting. All cases of declaration of interests would be recorded in the minutes of the meeting.
- 3. The Vice-chairman reminded members of the public observing the meeting that the press areas set up on both sides of the screen in the conference room were reserved for use by media representatives who had registered and received stickers for identification. Other members of the public observing the meeting should remain in the public seating area.

#### II. Absence from Meeting

4. The Secretariat reported that Ms SO Ka-man had submitted a sick leave application and a medical certificate to the SSC. Her absence was approved by the SSC in accordance with Order 42(1) of the Standing Orders. No leave applications had been received from other Members.

#### III. Confirmation of Minutes of Last Meeting

5. As no amendments were raised, the Vice-chairman announced that the minutes of the 11<sup>th</sup> meeting of the SSC (2018-2019) were confirmed.

#### **IV.** Discussion Item

(A) Request for Additional Resources to Enhance Community

After-School Care Services

(SSC Paper No. 41/2019)

(Written Response of the Social Welfare Department)

6. The first proposer of the paper said that many parents were unable to

work full-time because they had to take care of their children after school. Although some schools and non-governmental organisations provided care services, the service places were in short supply. In view of the great demand for after-school care services by Tuen Mun residents, she requested that the Social Welfare Department ("SWD") provide after-school care sessions in vacant classrooms so as to release the manpower of dual-income families.

- 7. Members' comments and enquiries about the matter are summarised as follows:
- (i) To solve the problem, a Member found it necessary for the Government to allocate resources to study citizens' actual need for relevant services. Although some schools currently provided after-school care services until around 6 p.m., the majority of dual-income families found such services inadequate;
- (ii) A Member said that while many schools provided after-school care services until 6 or 7 p.m., parents should not shift their child care responsibility to schools or tutorial centres. In this regard, the Government might take reference from the principle of "ageing in place" and allocate resources in the direction of "child care in place" to let elderly people unleash their potential; and
- (iii) Given the heavy workload of school teachers, a Member suggested that schools only provide venues for care services while the SWD hire other workers to care for the children.
- 8. Miss Yondy LAI of the SWD responded to Members' comments as follows:
- (i) The SWD understood the needs of dual-income families for care services and had launched the Enhanced After School Care Programme ("ASCP") in December 2014. Under the measure, some of the ASCP operators were allocated additional resources to extend service hours on weekday evenings, Saturdays, Sundays and school holidays. Services included homework guidance, social and developmental programmes, and skill learning. The department would regularly review the service utilisation rate of each district and adjust service quotas. Regarding Members' request for using school premises flexibly for the provision of care

services, the department was open to such a suggestion. To meet the needs of the community, interested organisations were also welcome to apply for the ASCP;

- (ii) Apart from after-school care services, the SWD also carried out the Neighbourhood Support Child Care Project to provide parents in need with flexible child care services. In 2016, the department commissioned the University of Hong Kong to conduct a "Consultancy Study on the Long-term Development of Child Care Services" and the study had been completed. Taking reference from the recommendations of the study report, the Government proposed a series of measures to improve relevant services; and
- (iii) In March 2016, the SWD had launched a two-year Pilot Project on Child Care Training for Grandparents, which had attracted almost 600 participants. In 2019, the department planned to implement a similar project offering 1 200 places to help participants cope with child care difficulties and strengthen support for them and their relatives at the family level.
- 9. Members raised another round of comments, which are summarised as follows:
- (i) A Member suggested that the SWD step up collaboration with social welfare organisations in the district proactively and recruit elderly people to strengthen child care services;
- (ii) A Member pointed out that many schools already provided after-school care services and opined that they should receive additional resources from the Government; and
- (iii) A Member reiterated that parents should not shift their child care responsibility to schools and that schools might not have adequate resources to provide comprehensive after-school care services.
- 10. The Vice-chairman thanked the SWD's representative for her response and asked her to relay Members' views to the department.

- 17. Members noted the contents of the relevant report by the SWD.
- 18. The Government announced in the Budget of the current year an allocation of \$20 billion for the purchase of properties for social welfare facilities. Regarding this measure, a Member enquired about the SWD's work progress.
- 19. Miss Yondy LAI of the SWD said that the department would move a

motion on the measure in the Legislative Council's Finance Committee and report to the TMDC in due course.

- 20. Regarding the Day Care Centre for the Elderly and the Residential Care Home for the Elderly at Kwong Choi Market, a Member asked about the progress of the tender exercise and when the facilities would come into operation.
- 21. A Member enquired about the progress of the conversion of the former Kei Leung Primary School.
- 22. Miss Yondy LAI of the SWD replied that the Day Care Centre for the Elderly and the Contract Residential Care Home for the Elderly at Kwong Choi Market were expected to come into operation in 2020-2021 and the department would report the progress to the SSC in due course. Regarding the other enquiry, she would communicate with relevant colleagues and submit a report to the SSC afterwards.

(Post-meeting note: Regarding the conversion of the former Kei Leung Primary School, the SWD commissioned a consultancy for a detailed design in May 2019 and the works were expected to commence in the second quarter of 2020.)

## (E) Report on Crime Figures in the Tuen Mun District (SSC Paper No. 46/2019)

- 23. Members noted the contents of the relevant report by the Hong Kong Police Force ("HKPF").
- 24. Noting the continuous increase in the number of indecent assault cases this year, a Member was concerned that there might be repeat offenders and hoped that the Police would step up detection work.
- 25. A Member said that there were prostitutes lingering in the vicinity of San Hui and the situation was worrying. She suggested that the Police consider conducting decoy operations for investigations.
- 26. Mr LEE Wai-ming of the HKPF thanked Members for their comments and information. He would report to the HKPF and arrange for police officers to take follow-up action.

## (A) <u>Visit to Tung Wan Mok Law Shui Wah School cum Island Hostel in Area 2B, Tuen Mun</u>

27. The Vice-chairman said that the SSC would visit Tung Wan Mok Law Shui Wah School cum Island Hostel in Area 2B, Tuen Mun on 23 September 2019 in the afternoon.
