#### I. Opening Remarks

Mr LEUNG Kin-man, the Chairman of the TMDC, welcomed Members of the Social Services Committee ("SSC") to the first meeting of the SSC.

2. Mr LEUNG Kin-man said that according to the TMDC Standing Orders, a committee should elect its chairman and vice-chairman at the first meeting of the committee in each term, and the TMDC Chairman should preside over the meeting for the election of the committee's chairman and vice-chairman. Therefore, he stated that he would preside over this meeting until the Chairman and Vice-chairman of the SSC were elected.

#### II. <u>Election of SSC Chairman</u>

- 3. Mr LEUNG Kin-man said that Section 71(3) of the District Councils Ordinance stipulated that a committee of a District Council ("DC") was to elect a member of the committee who was also a member of the DC as the chairman of the committee.
- 4. On 17 November 2017, the Secretariat had sent the membership lists of all the committees and the nomination forms for the chairmen and vice-chairmen of the committees to all Members. The nomination period had closed on 8 December 2017 and the Secretariat had sent the list of the validly-nominated candidates to all Members for reference on 11 December 2017.
- 5. The Secretariat had received one nomination for the SSC Chairman by the end of the nomination period. Mr CHU Yiu-wah nominated Ms SO Ka-man as the SSC Chairman, and the nomination was seconded by Ms LUNG Shui-hing and Ms CHING Chi-hung.
- 6. Since there was only one Member nominated as a candidate for the SSC Chairman, Mr LEUNG Kin-man announced in accordance with the TMDC Standing Orders that candidate Ms SO Ka-man was elected uncontested as the SSC Chairman for a term starting from the date of this meeting until 31 December 2019.

#### **III.** Election of SSC Vice-chairman

- 7. Mr LEUNG Kin-man said that pursuant to Order 33(3) of the TMDC Standing Orders, a committee might elect a member who was also a TMDC Member as the vice-chairman of the committee.
- 8. The Secretariat had received one nomination for the SSC Vice-chairman by the end of the nomination period. Ms CHING Chi-hung nominated Mr TSANG Hin-hong as the SSC Vice-chairman, and the nomination was seconded by Mr MO Shing-fung and Mr KAM Man-fung.
- 9. Since there was only one Member nominated as a candidate for the SSC Vice-chairman, Mr LEUNG Kin-man announced in accordance with the TMDC Standing Orders that candidate Mr TSANG Hin-hong was elected uncontested as the Vice-chairman of the SSC for a term starting from the date of this meeting until 31 December 2019.
- 10. As the SSC Chairman and Vice-chairman had been elected, Mr LEUNG Kin-man handed over the chair to the SSC Chairman.

[The SSC Chairman presided over the meeting from this point onwards.]

11. The SSC Chairman thanked Members for their support and trust and said that she

would continue to serve the residents of Tuen Mun District with diligence.

# IV. Other Business and Date of Next Meeting

12. There being no other business, the Chairman announced the close of the meeting at 9:54 a.m. The next meeting would be held at 9:30 a.m. on 16 January (Tuesday) this year.
